Re: A Motion by Dr. Shoenberg on Peary High School

Dr. Shoenberg moved and Dr. Cronin seconded that Peary High School be retained through the 1985-86 academic year, postponing the assignment of students to Wheaton High School and making adjustments in the attendance area of Rockville High School in order to maintain a high school of a viable size at Peary.

Mr. Ewing asked that the record show that it was his strong conviction that while the Peary community would think the Board quite wrong if they did not sustain the motion that was in front of them, or even from their point of view a better outcome would be to keep Peary open permanently, he was sure they would think it was wrong. He hoped that they would recognize that the Board had been honestly looking for reasonable solutions and that there had been no conspiracy, dishonesty, deceit on the part of the Board in any way, at least as far as he was aware. He thought it was important for that to be on the record and for the public to understand whatever else they did they did it in the interest of education. He thought that had been true of Boards in the past. They may have often looked to be making mistakes and in his view had often made mistakes, and he had made his share of them. But they had not been mistakes which had been the consequence of deliberate efforts to undermine public education or to do harm to students.

A motion by Dr. Shoenberg that Peary High School be retained through the 1985-86 academic year, postponing the assignment of students to Wheaton High School and making adjustments in the attendance area of Rockville High School in order to maintain a high school of a viable size at Peary failed with Dr. Shoenberg voting in the affirmative; Dr. Cronin, Mr. Ewing, Dr. Greenblatt, Mrs. Praisner, and Mrs. Shannon voting in the negative (Mr. Hirsch voting in the negative).

Re: Peary Instructional Program

Dr. Greenblatt moved the following which was seconded by Mrs. Praisner:

WHEREAS, The Board of Education adopted a resolution on November 4, 1981, stating:

Resolved, That Peary and Northwood High Schools, insofar as possible, duplicate the offerings of their respective receiving schools so that no student is denied access to courses because of the closure to transfer; and

WHEREAS, Peary High School is presently scheduled to close in June, 1984; and

WHEREAS, The number of students will be greatly reduced in total and in each grade; now therefore be it

Resolved, That the instructional program at Peary High School should provide for a full seven period day; and be it further

Resolved, That the range of courses available to students at Peary High School in 1981-82 should be considered as the baseline program for future years, and the school should be staffed to support the baseline program and not on the basis of enrollment; and be it further

Resolved, That students enrolled at Peary High School in 1983-84 should be eligible to enroll for courses at the vocational/technical center when the center opens in September 1983; and be it further

Resolved, That provisions will be made for Peary High School students to participate in the normal range of extracurricular activities provided in Montgomery County high schools.

For the record, the superintendent stated the intent was to support an extracurricular program similar to their intent on the instructional program. This was not to say that Peary would have to have every extracurricular activity that every school had, because no school had all extracurricular activities available to students in the County. In regard to the instructional program, they would not reduce courses for students, and if they had to run a class with eight students they would do it. They were going to have the same extracurricular activities at Peary as they had in 1981-82 as a guideline as they were going to have the same instructional program. The point was not to increase offerings, but not to penalize the youngsters because they happened to be attending a school that was closing.

Resolution No. 276-83 Re: Blair-Einstein-Springbrook
Attendance Areas

On motion of Dr. Cronin seconded by Mrs. Shannon, the following resolution was adopted with Dr. Cronin, Mr. Ewing, Mrs. Shannon, and Dr. Shoenberg voting in the affirmative; Dr. Greenblatt and Mrs. Praisner abstaining (Mr. Hirsch voting in the affirmative):

Resolved, That Dr. Cronin's memo entitled "Blair-Einstein-Springbrook Attendance Areas" dated March 21, 1983, be used as a framework for the Board of Education for action on attendance areas.

For the record, Mr. Ewing stated with respect to the proposal they note in 1985-86 the Blair projected enrollment is 2,021 for a four-grade high school. Of that 2,021 some substantial proportion, about 100, are magnet school students. Dr. George Fisher explained that that 2,021 would have 100 estimated. This would be the ninth graders only in 1985. Mr. Ewing said that the minority percentage figure with the magnet in place would be 46 percent in 1985. Dr. Fisher explained that the 46 percent figure assumed that all of these changes were in effect this current school year. Therefore, there was about a 7 percent improvement if Blair had 370 magnet students this year and all the boundary changes proposed were in effect this year. This would bring Blair's minority percentage down 15 percent. In 1985 it would depend on what changes would occur between now and 1985.
