Ms. Debra Haffner, vice-chair of the Title IX Advisory Committee, explained that Nadine Mildice, the chair, had a prior commitment and was unable to attend. ptional in terms of their achievement and maturity levels, yet they had told the Board of sexist remarks in the classroom, of guidance that was skewed because they were girls, of inappropriate physical contact by teachers, and of subtle harassment. She wo dressed down by a male teacher who was infuriated that she might have been talking about him, and the other had to sit through a class where her comments were dismissed as silly. One principal asked to meet with one of the young girls , not to find out more about her concerns and to see what he could do to change the situation, but to express dismay that her comments had been picked up by the press. Both students reported feeling intimidated because of speaking out, and both of them chose not to speak tonight because they wanted to avoid further harassment.

Ms. Haffner stated that sexism existed in schools, and they were asking the Board to speak out and say they would not tolerate it. She noted that less than 10 percent of the teachers in the school system had participated in the training workshops on sex equity and sexual harassment. A study by American University professors revealed that boys received special attention in the classroom and used over two-thirds of the classroom discussion time. With only three days of training, most teachers could unlearn this behavior. Less than one third of
