Ms. Delores Wishnowski, clerk of the court, administered the oath of office to Ms. Serino.

Re: STATEMENT BY MS. SERINO

Ms. Serino made the following statement:

"I do have many people that I would like to thank. First I would like to thank my family and my friends, all of whom have been very supportive this past year and throughout my life. Also, the 11 past Board members, especially the ones that are here today, thank you very much for paving the way that you have these past 11 years. You have really given the position much honor and much respect. I hope I can continue to do so in my year of service. In particular, I would like to thank Chan Park who has given me many words of wisdom and who has also paved the way this last year. He will be a very tough act to follow. I would also specifically like to thank him for his work to earn the student Board member the limited voting rights. He has been an active member in leading this lobbying effort that has made this a law. Next year I will have limited voting rights. It is a great challenge, and I hope that I will be able to accept it. I am looking forward to accepting this challenging in the future,

specifically next Tuesday.

"I would also like to thank all the people from my past schools that I have attended and the people that I have worked with in student governments throughout my years who have given me a lot of guidance and support. Re: WELCOME AND FAREWELL COMMENTS

Board members and Dr. Pitt welcomed Ms. Serino to membership on the Board of Education and thanked Mr. Park for his efforts during the past year. Dr. Cronin presented Mr. Park with a collage and a certificate of appreciation. On behalf of the County Council, Mr. Gudis presented Mr. Park with a proclamation listing his academic accomplishments and his service to the people of Montgomery County.

Re: STATEMENT BY MR. PARK

Mr. Park made the following statement:

"Last year at a reception for myself as well as for Andy Herscowitz, the outgoing Board member, I remember meeting the past student Board members. I remember each one of them coming up to me with a smile, the same smile, saying, 'good luck, Chan." Their smile seemed to say it all. It is hard to explain, but I guess in a nutshell it said, 'good luck, have fun, make the most of it, and this is a big responsibility, Chan, so don't screw it up.'

But I am confident the Board will work closely with the student to make sure that the transition is a smooth line and a successful one.

"Last but definitely not least, of course, are my family and friends. Without my friends I would not have maintained my sanity throughout the year. And without my parents and their love and their patience and understanding, I would not have made it. So I say thank you. "And now I would like to wish Alison the best of success for the year to come, and to Alison I can say with a smile, 'good luck, Alison.' I am sure you will do a super job. And to her parents I wish you the best of luck and I give you my condolences."
