Mr. Hwang introduced Mr. Xie as the new Student Member of the Board (SMOB). Mr. Xie commented that he has received a very warm welcome, and he looks forward to working with the Board.

Mrs. O'Neill welcomed Mr. Xie, and she expressed the Board's excitement at working with another SMOB. In turn, all Board members welcomed Mr. Xie.

Mr. Durso commended the Board's officers and the superintendent's team for guiding the Board through approval process of the operating budget.

Mr. Kauffman agreed with Mr. Durso, and he noted that there are still a few things to iron out in the budget.

Ms. Berthiaume congratulated Rockville High School for winning the *It's Academic* Super Bowl. She attended the dedication of Cashell Elementary School which was a very nice ceremony. Finally, she attended the MCCPTA Presidents and Principals Dinner, and she commented that PTAs make a difference in MCPS schools.

Dr. Docca echoed the comments of her colleagues on the operating budget. She attended the (1) Black and White Breakfast Buffet, which is a scholarship organization; (2) George B. Thomas, Sr. Learning Academy golf tournament; (3) the graduation ceremony for the Superintendent's Leadership Program; and (4) a meeting of the Damascus Connection Committee of Montgomery County.

Ms. Brandman commented on the MCCPTA Presidents and Principals Dinner, and she thanked the outgoing president, Kay Romero.

Mr. Barclay associated his remarks with those of his colleagues. He attended the dedication of William B. Gibbs, Jr. Elementary School, and he commented on the importance of naming a school after a person who has contributed to education in Montgomery County and other places.

Mrs. O'Neill noted the 10th Anniversary Celebration of the Skillful Teacher and the Professional Growth System (PGS). Also, the Broad Foundation commented on the PGS and support for teachers. The County Council will take final action of the operating budget on May 27. Also, the Maryland State Board of Education will hear from Montgomery County on the maintenance of effort waiver on May 25. Mrs. O'Neill noted that students at New Hampshire Estates Elementary School had the wonderful opportunity to meet First Lady Michelle Obama and Mexico's First Lady Margarita Zavala when they visited the school to promote Mrs. Obama's health and fitness program for young people.

Dr. Weast commented on the procedure for the operating budget and efforts of the Board, especially the president and vice president. Mrs. O'Neill and he were both impressed with the gracious way that these first ladies interacted with the students—from running laps in the gym to sitting at the lunch table to share a meal of healthful foods. New Hampshire Estates earned the U.S. Department of Agriculture's Healthier U.S. School Challenge Award in 2009 for promoting good nutrition and exercise. A research team from the Broad Foundation met with MCPS staff, students, parents and community leaders during a four-day visit last week. The visit will help determine the winner of the distinguished \$1 million Broad Prize for Urban Education. MCPS is one of five school districts in the country chosen as a finalist for the prize, which provides \$2 million in scholarships for students. Finally, Dr. Weast reported that the graduating class of 2010 at Montgomery County Public Schools has earned \$220.8 million in college scholarships, to date—up more than 18 percent from last year.

Re: GOAL 1: ENSURE SUCCESS FOR EVERY STUDENT UPDATE ON ENGLISH FOR SPEAKERS OF OTHER LANGUAGES PROGRAM

Dr. Weast invited the following people to the table: Mr. Erick J. Lang, associate superintendent, Office of Curriculum and Instructional Programs; Ms. Sylvia K. Morrison, director, Department of Instructional Programs; Dr. Karen C. Woodson, director, Division of ESOL/Bilingual Programs; Ms. Kankou Keita, former MCPS ESOL student; Mr. Darryl L. Williams, principal, Montgomery Blair High School; and Ms. Galit Zolkower, ESOL resource teacher, Bethesda-Chevy Chase High School.

Staff explained that Montgomery County Public Schools (MCPS) has the largest English for Speakers of Other Languages (ESOL) program in the state of Maryland with a current enrollment of 18,039 students as of May 1, 2010. More than 60 percent of ESOL students are born in the United States, a number that rises to 82 percent for ESOL students in Grades pre-K–2. The Division of ESOL/Bilingual Programs focuses its efforts on three critical areas to ensure that ESOL students develop full proficiency in academic English to be successful in school, college, and the workplace: ESOL curriculum and instruction, parent outreach, and counseling.

Performance data show that ESOL students are benefiting from these efforts. Overall reading and mathematics Maryland School Assessment (MSA) scores have shown consistent improvement in the percentage of students performing at proficient and advanced levels in Grades 3–8 for the past five years (2005–2009). However, the decline in MSA performance at the middle school level underscores the need to redouble efforts to reach these students.

Requirements under the *No Child Left Behind Act of 2001* (NCLB) present common challenges for school districts across the nation, such as meeting the linguistic and academic needs of students who are simultaneously developing proficiency in academic English. Additionally, districts are challenged by the expectation that beginning level ESOL students meet high school graduation requirements in four years and that all ESOL students, regardless of their English language proficiency levels, demonstrate the same level of proficiency on reading and mathematics tests as their native English-speaking peers. These nationwide challenges, as well as requirements put in place by the Maryland State Department of Education (MSDE), present obstacles for the MCPS ESOL population, since research indicating that it takes five to seven years for students to acquire academic English is not taken into account. ESOL students are expected to master challenging academic content in English in the same amount of time and at the same levels as their native English-speaking peers, and schools are penalized when their graduation rates are impacted by ESOL students who need more time to complete graduation requirements because of their English language proficiency level.

MCPS continues to advocate before MSDE for increased time for ESOL students to master English and meet graduation requirements and continues to strengthen its ESOL program and professional development opportunities for ESOL and general education teachers.

Re: **DISCUSSION**

Mr. Durso asked about the low number of ESOL student in middle school. Staff explained that the number is based on only three grades.

Mr. Barclay inquired about the FARMS and ESOL enrollment. Does MCPS have an understanding and accurate count of those students who are both FARMS and ESOL and Ever-FARMS and Ever-ESOL combined? That is a particular population that comes to

MCPS with a particular need. Staff volunteered to get the data. Mr. Barclay pointed out that not all ESOL students are poor. Mr. Hwang asked how MCPS works with community partners and nonprofits to help students succeed. Staff explained that community partners support students in areas that are outside of the realm of education, such as medical assistance.

Ms. Berthiaume noted MSA results and the gaps with LEP students. In assessing how well MCPS is implementing ESOL, she asked if there were follow-ups every seven or ten years to determine how graduates/dropouts are doing in post-MCPS life. Staff stated that has not been done, and it is the next step.

Ms. Brandman inquired about students moving up in grades and taking content courses. Does the ESOL curriculum focus on English language instruction or ESOL support content teaching? Staff stated that the ESOL curriculum is aligned to the Maryland English language proficiency standards. MCPS has aligned the curriculum to those LEP standards but exceeds the standards to make sure the rigor needed is in place.

Ms. Brandman asked about ESOL students who do not understand something in science. Where can that student find help? Staff stated that content teachers are about to differentiate instruction so that students are able to learn the language and content at the same time.

Ms. Brandman noted there was reference in the paper about advocacy with MSDE because there needs to be more time to attain academic English. It was agreed that the Committee on Special Education will draft a resolution and bring to the Board in June.
