PRESIDENT'S MESSAGE



A Special Thank You to our Board of Directors, who are working hard for all of us. A group of us traveled to Annapolis to attend the MRSPA Legislative Workshop. We gained lots of information and learned strategies that we can use as we communicate with our legislators. We also participated in the MRSPA Postcard Campaign – "Don't

Shift Retirement Funding." Recently, a small group met with Senator Rich Madeleno to discuss our position on pensions.

Some attended the George B. Thomas, Sr. Learning Academy Saturday School's 25th celebration. The Saturday school provides tutoring and mentoring services to over 3,000 Montgomery County students annually helping to prepare them for college and career readiness.

Ten Board members attended the Committee for Montgomery Annual Legislative Breakfast. Speakers were Montgomery County Executive Ike Leggett, U. S. Senator Benjamin Cardin, U. S. Representative Chris Van Hollen, and Maryland Senate President Thomas V. Mike Miller, Jr. We were introduced to many people and talked with some of those who attended.

Two Board members attend the Employee Retirement Planning Session each month. We give a short talk about what MCPSRA does for all retirees. Our recruiting brochure is available for all.

The Political Action Committee met with those running for Board of Education in the Primary Election. They have a set of questions to ask candidates. Their replies are noted and discussed and recommendations are made to our members.

Scholarship Committee has prepared an announcement of available scholarships for 2012. It will be distributed to all MCPS employees. After applications are mailed in, they will be read and evaluated. The top applicants will be interviewed for the scholarships which are given in June.

Our membership numbers have decreased due to deaths. This means that we need to recruit more members. If you are a member, invite a retiree to an MCPSRA Luncheon. If you are not a member, why not come to one of our luncheons as our guest! If you plan to attend as a guest, notify a Board member, so you can be included in the reservation count. 2012 Elections

Every two years, the Association's Political Action Committee (PAC) invites candidates who are running for office to complete a questionnaire and to interview with the committee. We do this as a service to members because many of the candidates and their positions on issues of interest to MCPSRA are not well known, and for many of us, it's difficult to get information about those individuals for whom we will have an opportunity to vote. This year we interviewed only Board of Education candidates.

Based on the candidates' questionnaire responses and interviews, the PAC is making the following recommendations for Board of Education:

BOE At-Large: Phil Kauffman

**BOE District 2: Jeanne Ellinport or Fred Evans
(vote for one)**

BOE District 4: Christopher Barclay

Both Mr. Kauffman and Mr. Barclay are incumbents who have supported MCPSRA positions. Ms. Ellinport and Mr. Evans are new and both demonstrated knowledge of retirees' issues and the challenges which face us as well as Montgomery County Public Schools. They deserve your support.

The Primary Election is Tuesday, April 3, 2012.

Everyone can vote for Board of Education. If you are registered without party affiliation, you can vote in the Primary for BOE. Even though candidates must run in a particular district, every registered voter may vote for all Board of Education candidates.

The District 4 race will not appear on the ballot in the Primary Election because there are only two candidates. In the other races, the top two vote getters in the Primary will be on the November ballot.

New Superintendent to Headline Program for February 23 Luncheon

Our February 23 luncheon will include the premiere MCPSRA appearance of our new Superintendent, Dr. Joshua Starr, as its featured speaker.

Dr. Starr is a passionate champion for all students and is committed to ensuring that Montgomery County Public Schools meet the needs of students across the spectrum. This appointment builds upon the work Dr. Starr began as a teacher in 1993 and has spanned a variety of educational positions. Dr. Starr was the superintendent in Stamford, CT, (2005-2011) where he distinguished himself by increasing student achievement for all subgroups, emphasizing increased academic rigor, standardizing curriculum, advancing the use of technology, creating business and civic partnerships, and emphasizing community and family engagement efforts aimed at supporting all children in the classroom.

Previously, he served at the executive level in the New York City Department of Education, the largest school system in the nation, where he held the position of Director of School Performance and Accountability. Dr. Starr also served New York City as Deputy Senior Instructional Manager.

Dr. Starr began his career as a special education teacher in the New York City Public Schools working with severely emotionally disturbed adolescents. He has also served in administrative roles in Plainfield, New Jersey, and Freeport, New York. A self-professed life-long learner, Dr. Starr brings enormous energy, intellect and enthusiasm to his new post as superintendent of schools for MCPS. He holds a doctorate degree in administration and social policy from the Harvard Graduate School of Education and has published articles in many journals in the field of education.

LEGISLATURE IN SESSION! WATCH OUT!

The Maryland General Assembly convened January 11 and will be in session through mid-April. Some issues they consider could have an important effect on retirees.

A *Gazette* article in early January said Governor Martin O’Malley “is weighing a proposal to shift some of the pension costs for the state’s public school teachers to the local governments that employ them.” If that happens, it won’t affect our pension benefits, but it could reduce or eliminate our health benefits.

The state may seek to shift some pension costs to the counties because those costs have risen sharply in the last decade. With more aid to education (the so-called “Thornton Act”), teacher salaries have been increased. When that happened, the amount that must be set aside for their pensions increased, too. Teacher pension, debt service, health, and transportation costs are the big drivers of the continuing budget deficits that Maryland has seen for many years.

Senate President Mike Miller has proposed the pension cost shift for several years—unsuccessfully. But, if the governor proposes it, the shift may happen.

Why would retirees’ health care costs be affected? As you know, MCPS retirees pay 36% of the cost of our health benefits; the school system/county pays the remainder. But they don’t have to. There is no law that requires local boards of education or counties to pay any of their retirees’ health care. They do it because it’s the right thing to do. But, if the county got saddled with an additional \$90 million (in Montgomery’s case) of education-related costs, it may look for places to reduce or eliminate non-mandated costs.

The problem is, some legislators don’t even recognize this problem. At the MRSPA Legislative Workshop in November, the House chair of the Joint Pension Committee didn’t know that retiree health costs were paid by local boards. She thought teachers and retirees were part of the State Employees health system. State employees and teachers are part of the same retirement system; some may think we’re part of the same health system. We are not!

You need to make sure your legislators know this important fact! Call or write them today. The easiest way to communicate with them on this issue is to use the MRSPA website. Here’s how.

1. Find the MRSPA website at www.mrspa.org. If you don’t know how, go to your library or ask a teenager.
2. On the MRSPA home page under Member Access, sign in by entering your MRSPA member number (in the address block of your state newsletter) in the “Username” block. In the “Password” block, enter the beginning initial of your first name and your last name with no space in between.
3. In the Members Area, click the TAKE ACTION box. That should bring up your state legislative district number. Click on CONTINUE. You should see the names, addresses, Annapolis telephone numbers and e-mail addresses of your delegates and senator. To send each an e-mail, click on the box next to their name.
4. Then, under “E-Mail Templates” click on “DO NOT SHIFT RETIREMENT FUNDING” for a “canned”

message, or “Compose Your Own Message”. Click on Continue and you will see the message or a space to write one. Click on Continue again to send the e-mail.

If your delegates and senator don’t get your e-mail about this important issue, they won’t understand the problem and may not think we care.

We also participate in regular reviews of potential new offerings, bid specifications and plans for new or continuing services, MCPS User Satisfaction Surveys, etc.

One of our primary functions is to understand the various insurance plans and offer assistance to members who have questions or concerns that they feel are not being addressed by MCPS through "normal" channels. We are always glad to discuss individual or group concerns and to follow up with MCPS staff to seek further clarification and resolution to our members "problems". YOUR TRAVEL INFORMATION

PLEASE TAKE TIME TO READ THIS IMPORTANT INFORMATION. SHARE IT, ALONG WITH SPECIFIC TRIP INFORMATION, WITH YOUR GUESTS.

- 1. We all travel at our own risk.
2. There is always some walking involved as we travel. Read each itinerary carefully, keeping in mind your own capabilities.
3. Itineraries, times and details are approximate. Changes are sometimes necessary and unavoidable.
4. Trips are open to members, their families and friends (adults).
5. Smoking and drinking of alcoholic beverages are not permitted on the coach.
6. About three to five days before a day trip, participants are called to remind them of the day and departure time of the trip. For overnight coach trips, about two weeks prior to the date of departure, you will get a letter with up-to-date information, including parking details. One baggage tag per person will be mailed to you.
7. Write a separate check, payable to MCPSRA, for each trip. Include name and date of trip on check...
8. Send check with completed reservation form.
9. Your reservation is definite upon receipt of deposit/full payment, whichever is required.
