1. Mr. Ewing said the Board had received correspondence from Mr.

Malcolm Lawrence and others dealing with intrusions into student

privacy. He continued to receive inquiries on this issue and would like to know where matters stood and when the Board could expect to receive a response. People had suggested it would be useful for the Board to take a position on that issue prior to acting on the recommendations of the committee on special programs. Mrs. Praisner replied that the K-12 recommendations had been on the agenda for several months for Board consideration in February. The materials had been sent out to the community for comment prior to Board consideration. Mr. William Henry, director of the Department of Information, commented that the deadline for citizen comment was November 30.
