Re: FINAL UPDATE ON LEGISLATION

In addition to the paper provided in the packet regarding the bills on which the Board had a position, Ms. Lori Rogovin, legislative aide, briefed the Board on the final actions of the General Assembly. Ms. Rogovin thanked the Board and staff for their input, feedback, and testimony during the legislative session. Ms. Rogovin gave a brief update on the following:

Bridge to Excellence in Public Schools Act (SB 856) established by the Commission on Education Finance, Equity, and Excellence (the Thornton Commission). SB 856 restructures the state-s public education financing system and phases in enhanced state aid over a period of six fiscal years. By fiscal 2008, the state will provide an additional \$1.3 billion in education funding to local school systems above what the state would have provided under the existing state aid structure. The tobacco tax increases the tax on a pack of cigarettes from 66 cents to \$1, beginning June 1, 2002. The increased tax rate is expected to generate approximately \$101.4 million in FY 2003, and the first \$80.5 million it generates will be placed in a special fund that will be used to provide money for SB 856.

The increased local flexibility provides local school systems with education funding through flexible block grants and requires the Maryland State Department of Education to track more closely student performance among all student populations. Fiscal 2003 Bridge funding provides for \$80.5 million in additional state aid for education in fiscal 2003, including \$64.7 million in unrestricted grants. The Foundation Program changes the name of the program that funds a base per pupil amount for all students in the state from the Basic Current Expense Program to the Foundation Program. In FY 2004, the state share of the Foundation Program will be increased for certain jurisdictions. Beginning in FY 2005, the state share of the Foundation Program will be adjusted to reflect cost differences identified in the development of the index.

Programs for Students with Special Needs enhances the amount and proportion of state aid that is based on special education, limited English proficient, and economically disadvantaged student enrollments. By FY 2008, no school system may receive less than a 40-percent state share of the per-pupil amounts identified in the formulas. Enhanced Student Transportation Aid enhances state aid for base student transportation grants as well as grants for the transportation of students with disabilities. The base transportation grant is enhanced for 15 counties that had aggregate enrollment increases between 1980 and 1995. The amount each school system receives per student who requires special transportation services is increased from \$500 to \$1,000 by FY 2008.

Affirmation of the state's Ability to Provide Funding requires the General Assembly to affirm by joint resolution during the 2004 legislative session that the FY 2005 aid amount is within the state's fiscal resources. Accountability requires each local school system to develop a comprehensive master plan.

The Kindergarten/Pre-Kindergarten section requires every school system to provide full-day kindergarten for all students by the 2007-2008 school year. Also, by the 2007-2008 school year, each school system must make publicly funded pre-kindergarten programs available to all economically disadvantaged 4-year-old children.

Task Force to Study Public School Facilities (HB 937) would establish a new allocation for grants distributed under the Aging Schools Program and create a task force to look at facility issues. This legislation would hurt 17 school systems, and a strategy to have the governor veto the bill is being pursued.

Collective Bargaining (SB 233) authorizes local boards of education and local school employee organizations representing certificated and noncertificated school personnel to negotiate over mutually agreeable matters other than salaries, wages, hours, and working conditions. However, local boards may not negotiate the school calendar, class sizes, or matters precluded by statutory law. If either party declines to negotiate a permissive item, it cannot be subject to an impasse.

Maryland Infants and Toddlers Program (SB 419/HB 371) establishes a state funding formula for the Maryland Infants and Toddlers Program to provide grants to local agencies.

Adult Education (SB 737) requires MSDE to distribute competitive grants for adult education services according to the state plan for adult education and family literacy.

Principal Training (HB 7) establishes a Principal Training Pilot Program for three years, beginning July 1, 2002.

Task Force to Study Student Behavior Interventions (HB 569) requires the state superintendent of schools to appoint a task force to propose regulations to the state board regarding student behavior intervention practices, including the use of restraint, seclusion, time-out, and other disciplinary measures

Pepper Mace (HB 1377) repeals the provision and penalties under the criminal law article that prohibits a minor from possessing pepper mace, either openly or concealed and states that it is the intent of the General Assembly that a school or school board of education may establish policies to limit or prohibit the possession of pepper mace on school property.

HB 706 B Montgomery County B Board of Education B Compensation (MC 204-02 B Montgomery County Delegation) increases the annual salary of elected members of the Montgomery County Board of Education to \$22,500 for the board president and \$18,500 for the other elected members (phased in upon election to a new term). In addition, Board members would be entitled to health insurance and other fringe benefits regularly provided to Board employees. The bill also provides that a student Board member who completes a full one-year term on the Board will receive a \$5,000 scholarship to be applied toward the student-s higher education costs.

HB 712 B Montgomery County B Board of Education B Redistricting (MC 205-02 - Montgomery County Delegation) redistricts the five Montgomery County Board of Education districts from which five school board members are elected, which is required to occur every 10 years following the decennial U.S. Census.

Mr. Felton thanked Ms. Rogovin for her tremendous work on behalf of the Board. She had devoted many hours over the last 90 days and had promoted the Board=s position on proposed legislation. Mrs. King and Mrs. O=Neill congratulated and thanked Ms. Rogovin for her assistance to the Board and delegation.

RESOLUTION NO. 135-02 Re: FIRE SAFETY CODE B INSPECTIONS B SCHOOLS

On recommendation of the Superintendent and on motion of Mrs. O=Neill seconded by Mrs. King, the following resolution was adopted unanimously:

WHEREAS, The safety of students and staff is a paramount priority for the Board of Education; and

WHEREAS, Compliance with applicable life safety and fire safety codes provides a safe learning environment; and

WHEREAS, The Montgomery County Fire Marshal and the City of Rockville are currently

conducting a special series of fire inspections of all Montgomery County Public Schools buildings; and

WHEREAS, Many schools have received citations of fire code violations; and

WHEREAS, Emergency Bill 8-02, Fire Safety Code B Inspections B School, has been introduced for Montgomery County Council consideration: and

WHEREAS, Emergency Bill 8-02 would mandate the Montgomery County fire marshal to conduct annual fire code inspections of all schools; and

WHEREAS, The modernization schedule for schools with the greatest facility needs has been delayed, thereby increasing the maintenance and compliance requirements; therefore be it

Resolved, That the Board of Education supports and welcomes the assistance of the fire marshal to inspect all school facilities as frequently as necessary to ensure compliance with the applicable fire safety codes; and be it further

<u>Resolved</u>, That once compliance has been achieved, the Board of Education supports annual spot inspections and, as often as deemed necessary by the fire marshal, full inspections to ensure compliance with all applicable fire safety codes.

Re: EDUCATIONAL FACILITIES OFFICERS

Mr. Michael Subin, County council member, and Ms. Saralee Todd, special assistant to the

county executive, presented the county executive-s intention to submit a proposal for federal funding of educational facilities officers within the Police Department. The federal funds are intended to be used to assign 32 police officers to geographic beats across the county to focus on the improvement of emergency preparedness among several county agencies, including the school system. Within an officer-s geographic beat, he or she will be responsible for public schools, private schools, and Montgomery College campuses. Any deployment of such officers will be with the full collaboration of the schools and community, in an effort to increase communications, planning, and security of MCPS students and school staff.

Re: **DISCUSSION**

Mr. Abrams was not opposed to the concept. He asked if the cost would always be borne by either the federal government or an agency other than the school system. Mr. Subin replied that federal grants end, and this program is not envisioned to be part of the MCPS budget. It would be part of the county executive=s budget within the Police Department.

Mr. Abrams thought the description of the position was public safety, not police. He asked if the skills identified would be from new recruits or reassignment of personnel. Mr. Subin responded that the educational facilities officers would receive normal rookie training through the county. The federal training will equip an officer to respond to emergencies for which they would be assigned to an educational facility. There would be some additional duties in working with those facilities to develop an emergency plan.

Mr. Abrams stated that the officers would not be assigned to the school full time. They would be assigned to the Police Department for regular duty, but in the event of an emergency their first duty would be to an educational facility. Mr. Subin answered that they would be treated as any other special unit B police officers that have received specialized training for a specific duty.

Mr. Felton wanted to clarify that the officers would not be at the school except for an emergency. Ms. Todd added that the officers would go from school to school to make sure the plans were in place, to have discussions with staff, and to familiarize themselves with the building and the student population.

Mr. Burnett asked what the officers would do during the year in the absence of a tragedy. Mr. Subin said they would be normal beat officers who would be trained for emergencies. To help them handle an emergency and gain the confidence of the staff, the officers would need to spend some time at the school. Mr. Abrams thought he was hearing that they would be regular police officers who have the responsibility within the department for these activities.

Mr. Jeter recalled past concerns about police officers in the schools, but this is a different plan. Mr. Subin explained that if the officers are seen in the school for an extended period of time, they would not be doing their job. While the federal government is calling this an SRO (school resource officers) grant, the county executive envisions a different utilization of the police officers.

Mr. Felton asked if the educational facilities officer or other police would respond to the school for a typical call for assistance. Mr. Subin replied that there would be other officers but the educational facilities officer would take the lead.

Ms. Cox asked about the training for the educational facilities officer. She noted that it included child development, community outreach, cultural awareness and sensitivity, student/adult communication, and community mediation and problem-solving strategies. She thought this was prevention. What role will the officer play? Ms. Todd replied that the federal government provides training under this program to help these officers. In Montgomery County, the officers will not be patrolling schools but will focus on emergency preparedness activities at a variety of schools, which is an extension of community policing.

Mr. Burnett had heard concerns about the past SRO position; for example, when the person is in the building who would be in charge of discipline issues. Ms. Todd explained that a Memorandum of Understanding would be developed for the grant.

Mr. Burnett stated that most positions that prepare for disasters are civilian jobs. Why would this be a police officer? Ms. Todd replied that there would be coordination with overall management structure and in Montgomery County that means fire and rescue personnel, police officers, and health department personnel. Mr. Subin added that depending on the circumstance the police officer will work with a wide variety of agencies and personnel.

Ms. Cox asked about the funding for training and whether or not it was included in the federal grant. Ms. Todd said there would be no impact on the education budget.

Mrs. O=Neill told of an incident where a local school was Alocked down@because of a thief in the neighborhood. The police officers that responded were not familiar with the school and staff. She thought this would be an excellent situation for an educational facilities officer. She hoped that a September 11 type of incident would be extremely rare. Educational facilities officers are not school resource officers, and they will not be walking the halls with guns. The officers are assigned to a geographic area for all educational facilities. This is a federal grant that will not compete with local money. If the grant is not approved, there will be no educational facilities officers. Ms. Todd said the effort is to get federal funds for three years for educational facilities officers.

Mr. Felton remarked that any concerns between the county government and the school system could be addressed with the Memorandum of Understanding.

Mrs. King said that all her questions were answered and that having more police officers prepared for an emergency made her, as a citizen, feel more comfortable.

Mr. Abrams thanked Ms. Todd and Mr. Subin for coming to the Board with this proposal. He thought the concept was a Ano brainer. It would be a dereliction of duty not to have educational facilities officers in school buildings in the event of an emergency, especially since someone else will pay for it. Mr. Abrams thought that the reluctance to have exposure to police officers is totally misplaced.

WHEREAS, The federal funds are intended to be used to assign 32 police officers to geographic beats across the county to focus on the improvement of emergency preparedness among several county agencies, including the school system; and

WHEREAS, Within an officer-s geographic beat, he or she will be responsible for public schools, private schools, and campuses of Montgomery College; and

WHEREAS, Any deployment of such officers will be with the full collaboration of the schools and community, in an effort to increase communications, planning, and security of our students and school staff; now therefore be it

Resolved, That the Board of Education go on record in support of the concept of educational facilities officers as embodied in the grant application; and be it further

Resolved, That the Superintendent work with the County Executive to reach agreement on a Memorandum of Understanding that will delineate the use and deployment of educational facilities officers, ensuring that the interests of our students and staff are paramount, and, further, that guidelines be published that clearly define the relationship between such officers and principals and that ensure regular communication with the community; and be it further

Resolved, That the Superintendent submit the Memorandum of Understanding for the

approval of the Board of Education no later than May 14, 2002.

Re: **BOARD/SUPERINTENDENT COMMENTS**

Mr. Lange asked the superintendent to obtain the study on military school that was reported on A60 Minutes@ (April 21, 2002). Recently, there was a character education program at James Hubert Blake High School. In addition, Julius West Middle School students completed a tremendous initiative on service learning in which the students developed portfolios with parents and staff to build positive relationships. Also, he asked the superintendent to comment on Ms. Lyons=testimony and the special education training that teachers receive to implement accommodations.

Mr. Jeter participated in Seneca Valley High Schools Ethics Week. He spoke to the classes about being a Board member and listened to the students-issues. The election for the new student Board member will take place on April 24. The new voter registration drive is underway in the high schools.

Mr. Abrams thanked Larry Rosenblum for donating furniture and equipment to the school system.

Mrs. King attended the National School Board Association sconference at which Mr. Lloyd, a former student member of the Board of Education, and Mr. Jeter made a presentation, and those attending were in complete awe of the MCPS students. Dr. Williams, Dr. Arons, Ms. Merry and Mrs. King gave a presentation on professional growth.

Mrs. King requested that the Board receive an update on the MCPS career and technology programs.

Mrs. O-Neill commented on the rededication of several modernized schools. Also, she asked Mr. Bowers to comment on air conditioning in the schools. Mr. Bowers replied that staff had begun the conversion so the schools would be air conditioned in time for the MSPAP.

Mr. Burnett attended the NAACP Youth Summit, and he was very impressed with Ms. McEachem, who is 9 years old. She was very articulate with Mr. Burnett on her likes and dislikes of the school system.

Ms. Cox spoke about ethics and politics at Seneca Valley High School, and it was very interesting to talk with the students and hear their perceptions about Board members and their effectiveness. Also, she visited the biotechnology open house at Thomas S. Wootton High School, and it was a fabulous experience that underscored the work of MCPS to make connections to the real world.

Ms. Cox requested information on whether records are kept on complaints about secondary school teachers who are not implementing accommodations for students, and asked what the strategy is through staff development to make sure teachers carry out accommodations.

Mr. Felton asked for clarification regarding activity buses for ESOL students in the Sherwood Cluster. Mr. Felton noted that April was National Autism Month, and the Board signed a proclamation.

Dr. Weast commented that the kickoff of TECH CORPS MARYLAND took place earlier in the day at the Comcast offices in Silver Spring. This is a new MCPS partnership with TECH CORPS and the Montgomery County Business Roundtable for Education. It is designed to encourage businesses and individuals with expertise in technology to use their skills to support technology programs in schools. Ten businesses, agencies and individuals who are already making significant contributions were honored today with awards for their exemplary technology support to schools including teacher training programs and assistance with Web design.

Dr. Weast stated that it is important that every eligible child take advantage of this summers Extended Learning Opportunities program in the 18 Title I elementary schools in MCPS. The program is being called Summer Adventures in Learning, a name that is appealing to young children and their families. Summer Adventures in Learning is an important learning opportunity for these young children. He hoped to have 100% participation among the kindergarten through grade three children in the 18 targeted schools.

Dr. Weast thanked the Board for its efforts in class size; reading, writing and math, honors classes, new programs, and a commitment through the operating budget.

<u>Resolved</u>, That each of our high schools and middle schools develop a plan to discuss pedestrian safety and all of its ramifications annually (either at an assembly or through classroom discussion).
