Retiree Open Enrollment to Be Held OCTOBER 11-NOVEMBER 5, 2021

Montgomery County Public Schools (MCPS) will conduct benefits Open Enrollment for retirees from October 11 through November 5, 2021. Open Enrollment is your opportunity to make changes to your medical, dental, vision, and prescription plan options; to drop coverage; or, under certain circumstances, to add coverage that you previously dropped.

Benefit Plan Highlights

There will be no changes to insurance vendors or plans for 2022.

The Employee and Retiree Service Center (ERSC) will mail the 2022

Retiree Benefit Summary to retirees beginning the third week of September. The mailing will include detailed benefits information, including benefits-plan comparison charts; rate information; and an enrollment form to make changes to your current benefits. The updated summary also will be available online several days prior to Open Enrollment at www.montgomeryschoolsmd.org/ departments/ersc/retirees/benefits/ open-enrollment.aspx. Be sure to read the benefit summary as it contains important details about all of your retiree benefit options for 2022

MAKING CHANGES to Your Benefits During Open Enrollment

To make a change to your retiree benefits during Open Enrollment, you must complete and submit MCPS Form 455-22, Retiree Benefit Plan Enrollment, to the Employee and Retiree Service Center (ERSC) by Friday, November 5, 2021. Submit a signed enrollment form in any one of the following ways::

- Mail your signed form to ERSC at 45 West Gude Drive, Suite 1200, Rockville, MD 20850.
- Email an electronically signed form or a form that you have signed and scanned to ERSC@ mcpsmd.org.
- **Fax** your signed form to ERSC at 301-279-3642 or 301-279-3651.

During the plan year

Federal guidelines related to benefit plans established during the advent of Covid-19 in 2020 still are in place. This means that MCPS retirees still may make changes to their health insurance enrollments outside of Open Enrollment. To learn more about these changes and your options, visit www.montgomeryschoolsmd.org/ departments/ersc/retirees/news/ index.aspx?id=666202. ERSC will notify retirees if and when the federal guidelines allowing for year-round benefit changes are withdrawn.

Prior to Covid-19, you could only make changes to your benefit plans outside of Open Enrollment if you experienced a qualifying life event*. You had 60 days from the date of the event to submit MCPS Form 455-22, Retiree Benefit Plan Enrollment, to ERSC with required documentation. Changes submitted to ERSC by the fifth of the month went into effect on the first of the following month.

*Qualifying life events include divorce, loss of alternative coverage, change in work status, relocation outside of current plan's service area, retirement, or death.

HAVE YOU TAKEN the Wellness Initiative for 2022?

Complete your biometric health screening (or the alternative described below) and a health-risk assessment by October 8, 2021.

Are you a Montgomery County Public Schools (MCPS) retiree who is covered by an MCPS-provided medical plan and not yet eligible for Medicare? Have you taken steps yet to reduce your 2022 health insurance costs by completing a biometric health screening and online health-risk assessment as part of the Wellness Initiatives program? If so, congratulations! You will see a reduction in the cost of your health insurance next year when compared with the cost you would pay if you had not completed them.

If you have not completed your screening and assessment to lower your rates for 2022, you have until October 8, 2021, to do so. If you complete a health screening by the deadline, MCPS will pay an additional 1 percent of the total cost of your health insurance—reducing your contribution by 1 percent effective January 1, 2022. Likewise, by completing your medical insurance plan's health-risk assessment by the same deadline, MCPS will pay an additional 1 percent of the total cost of your health insurance, also effective January 1, 2022.

Alternative to Biometric Health Screening Available

An alternative way to complete your biometric health screening is available again this year for MCPS retirees. You have the option of completing Biometrics Incentive Alternative online training to receive Wellness Initiatives credit for the 2022 benefit plan year. Visit the Employee and Retiree Service Center web page at www.montgomeryschoolsmd.org/ departments/ersc/. Click on Biometrics Incentive Alternative found under Retirees/Most Requested and log in.

A 32-slide presentation will take between 20-25 minutes to complete. Simply scroll through and read the slides. When you are finished, follow the instructions to confirm that you completed the training. By doing so, you will pay 1 percent less on your health insurance costs in 2022.

The Biometrics Incentive Alternative training replaces a biometric health screening with your doctor. It does not replace your medical plan's online **health-risk assessment**. Retirees who still need to complete their online health-risk assessment have until **Friday, October 8, 2021**, to do so.

Follow these instructions to complete the Biometrics Incentive Alternative training in lieu of a biometric health screening:

- Visit www.montgomeryschoolsmd. org/departments/ersc/.
- 2. Click **Biometrics Incentive Alternative**, found under Retirees/Most Requested.
- 3. Click on **Biometrics Incentive Alternative Training** at the top of the log-in screen.
- 4. Scroll through the slides and read the health-care information.
- To record your completion of the training, return to the log-in screen and log in using your MCPS employee ID number and the last four digits of your Social Security number.
- 6. Click **Yes** to confirm that you have read through the presentation.
- 7. Click Save.

Learn More

You must complete a biometric health screening and health-risk assessment each year to maintain the rate reductions. To reap the program benefits in 2023, you will have between October 11. 2021, and October 7, 2022, to complete your screening and assessment. On July 1, 2021, retirees of the Maryland State Retirement and Pension System who had been retired at least one year and their beneficiaries received a cost-of-living adjustment (COLA) of 1.234 percent. Those who retired after July 2020 (August 2020 or later) will receive their first COLA increase in July 2022. For additional information, please visit https://sra.maryland.gov/news. Information concerning whether or not retirees and beneficiaries of the MCPS Retirement and Pension System will receive a COLA on January 1, 2022, should be available in November 2021.

NEED TO UPDATE YOUR BENEFICIARIES? Here is How

If you have recently experienced any significant changes in your life, you should consider whether or not you need to update your beneficiaries. If you do, follow the instructions below to update beneficiaries for your life insurance, 403(b) and 457(b) plans, and pension plans.

While the Employee and Retiree Service Center (ERSC) is the first stop for some of your beneficiary paperwork, we are not able to report or confirm the beneficiaries on your existing plans. If you are uncertain of your earlier decisions, submit a new beneficiary form to be sure that your wishes are in line with your beneficiary records.

TO CHANGE YOUR LIFE INSURANCE BENEFICIARIES-

- Submit MCPS Form 455-22, Retiree Benefit Plan Enrollment.
- Indicate your desire to change your beneficiaries in Section II and indicate your changes in Section VIII of this form.

TO CHANGE YOUR 403(B) OR 457(B) PLAN BENEFICIARIES WITH FIDELITY—

- Visit Fidelity NetBenefits® at https://nb.fidelity.com/public/nb/ mcps/home.
- Click **Update My Beneficiary** at the bottom right of the screen.
- Log in and follow the online instructions.

TO CHANGE YOUR 403(B) OR 457(B) PLAN BENEFICIARIES WITH ANOTHER VENDOR—

Contact your vendor. Forms must be submitted directly to your vendor.

TO CHANGE YOUR PENSION PLAN BENEFICIARIES-

- MCPS Core and/or Supplement pension plans—
- Submit MCPS Form 455-5, MCPS Core and/or Supplemental Pension Plans Designation of Beneficiary/Beneficiaries, to ERSC. Under plan rules, a beneficiary change is not permitted if you elected MCPS payment options C or D at retirement. These options pay a continuing monthly benefit to the designated sole survivor in the event of the retiree's death.

Are you planning a move?

Make sure to update your address with the Employee and Retiree Service Center (ERSC) by completing and submitting MCPS Form 445-1B, Change in Personal Information for MCPS Retirees and Former Employees.

You also will need to update your address with the Maryland State Retirement Agency if you receive a benefit from the state. Visit the ERSC Retiree Forms web page where you will find a link to the necessary form. From the ERSC website, click on **Forms** under Retirees: Most Requested. A link to the Maryland address change form is under Personal Information.

STILL SMOKING? Quitting Smoking Leads to a Healthier, Happier Retirement

Retirement should be filled with activities you didn't have time for during busy work days. This may include improving your health. Are you a smoker? Quitting is the best way to live and stay healthy in retirement.

Motivation to quit may come from children or grandchildren, from friends who have quit, or from society making it harder to smoke in public places. Motivation might come from your physician or from a personal health scare. But it is the motivation that comes from within that leads to the greatest success.

Quitting smoking can provide the foundation for your dream retirement. Studies indicate that modifying lifestyle factors, including quitting smoking, can reduce nursing home admissions. In one study, smoking in middle age increased the chance of admission by 56 percent.

Quitting also is a smart decision financially. Costs of cigarettes and associated taxes are constantly increasing. Quitting leaves you with more money in your pockets! Quitting can decrease health care costs with studies showing a savings of more than \$10,000 annually. In addition, nonsmokers spend an average of \$1,250 less annually for term life insurance.

Trying to sell your car or home? Smoking can devalue your assets. Many people will

not even consider buying a used car or home if the previous owner smoked.

Quitting is hard, but certainly possible and worthwhile. Research shows that quitting success doubled or tripled when a plan was used in combination with support and cessation medications.

Some tips to help you quit:

- Set a quit date.
- Discuss pharmacological aids with your doctor.
- Attend a smoking-cessation class. Well Aware, the MCPS employee wellness program, offers a free class. See details below.



- Enlist support from family, friends, or support group.
- Remove triggers and avoid negative influences (including people).
- Save the national smokers Quitline (1-800-QUIT-NOW) for immediate support.
