Enrollment growth in the southern portion of the Downcounty Consortium elementary schools requires classroom additions or a new elementary school. In November 2013, the Board of Education directed Montgomery County Public Schools' staff to study the feasibility of classroom additions at five elementary schools in the Downcounty Consortium study area. Seven other schools also are included in the study. The results of these studies will be compared to the cost of opening a new elementary school. The schools included in this study are listed below:

## Schedule of Meetings

#### **Elementary School Meetings**

The meetings at each elementary school are an opportunity for community members to provide input on the classroom additions being studied. At each school, the architect will present one or more concepts for the classroom addition. Comments will be recorded and the architect will incorporate any changes based on the input.

#### Capacity Study Follow-up

Following completion of the meetings, the architect will develop cost estimates for each proposed school addition. The cost of additions will be compared with the cost of a new elementary school. In Fall 2015, the superintendent of schools will make a recommendation on whether to construct additions at some schools, build a new elementary school, or a combination of both. The recommendation will be included as part of the *Superintendent's Recommended FY 2017–2022 Capital Improvements Program* (CIP) where funds and opening dates will be recommended.
