2.8 Evidence of use of mastery objectives & essential learning

2.12 Lessons that incorporate differentiation with activities tailored to developmental & learning needs, such as center work, anchor activities, small groupings, re-teaching, etc

2.15 Evidence of a critical thinking environment (e.g., room set-up, display of student work, posters, activities, centers)

3.2. Examples of emails or letter/notes sent home

3.5. Back-To-School Night packets		
3.6. Maintains attractive bulletin boards that display student work & demonstrates high expectations & respect of student accomplishments
