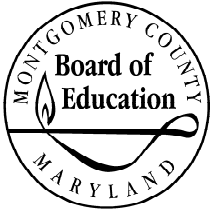

Purpose

The Montgomery County Board of Education has established the "Awards for Distinguished Service to Public Education" to recognize and show appreciation to individuals, groups, and businesses that have made exemplary contributions to public education in Montgomery County.

Eligibility

The *Individual Pioneer Award* is presented to an individual who may not be active currently, but who has made extraordinary contributions in the past, and whose impact has had a profound systemwide effect on Montgomery County Public Schools (MCPS) over the years.

The other awards go to an individual (including MCPS students), group, or business that has, within the past three years, provided sustained service, support, and commitment to public education in MCPS, as demonstrated by:

- An outstanding contribution of time and expertise to MCPS programs
- The development and/or implementation of an exemplary program or project
- A contribution that results in systemwide benefit

Number and Type of Awards

Up to three awards will be given in each of the following categories:

- **Community Individual**
- **Community Group**
- **Business**
- **MCPS Staff**
- **School Service Volunteer**
- **Individual Pioneer**

Who May Nominate?

Any person or group may submit nominations.

Process/Deadline
