
Our Montgomery County Public Schools (MCPS) students and staff have submitted a lot of creative, interesting, and informative entries for the annual *Watts Up?* poster contest sponsored by the School Energy and Recycling Team(SERT). More than 150 entries were submitted and our SERT program staff has completed the initial round of judging. We considered entries based on the following criteria:

- Was the artwork accompanied by an official contest entry form, with appropriate signatures?
- Does the artwork demonstrate recycling and/or saving energy?
- Does the artwork relay a good message about the importance of conservation?
- Will we be able to reproduce the artwork without losing its beauty and/ or message?

GET READY FOR PEAK LOAD MANAGEMENT




Montgomery County Public Schools (MCPS) has instituted a late afternoon curtailment of air conditioning operations in schools each summer from 4:00–5:00 p.m. We call this PLM, or Peak Load Management. Why would we do this? The answer is simple: the energy we use during peak hours in the summer affects MCPS' electricity costs year round! Because these peak summertime demand periods determine the price we pay for electricity for all 12 months of the year, conserving energy during the summer crucial.

The chart to the right reflects the increase in kilowatt hour pricing during the peak hours of 3:00–5:00 p.m. on a typical hot August afternoon. On this particular day, the electric demand approached, and briefly exceeded, the capacity of the power grid to generate and transmit electricity, resulting in a voltage reduction, or brown-out, to protect the system. At such times, the real -time price of electricity becomes very costly, rising from the normal \$0.10/ kWh and spiking up to \$0.75/kWh. This is a clear signal to customers to shut down all non-essential uses of power.


Every day from June 19 through August 24, please be prepared for PLM.

- Starting at 3:00 p.m., your staff should turn off all non-essential lights and equipment.
- From 4:00–5:00 p.m., each building's central plant equipment is curtailed for one hour. The chart below shows energy use increase and decrease as the chiller comes on at 6:00 a.m., shuts down for PLM at 4:00 p.m., and comes back on for evening activities.
- You can help by not scheduling activities from 3:00–5:00 p.m. during the summer.



The shutdown process for chillers should begin at 3:45 p.m. Chillers should be off from 4:00-5:00 p.m. If the chiller is still on at 4:00 p.m., please call the EMS Hotline at **301-252-3533**.

Thank you for doing your part to help MCPS save on electricity costs while helping to preserve the environment.

Spotlight



With proper paper recycling, your school has a chance to win a SERT recycling reward for the annual **GOT PAPER?** contest. All MCPS elementary, middle and high schools are automatically qualified to participate in the contest which runs the entire month of June.

You don't need to do anything special — just recycle your paper products as normal! Our recycling hauler weighs the dumpsters when they're serviced and provides SERT with the data so there's no need for you to worry about weight. Just keep filling your dumpsters up with paper recyclables!

REMEMBER THE FOLLOWING-

- Recycle all types of paper including spiral notebooks, composition books, magazines, colored paper, paper bulletin board decorations, theme paper, used copier paper, and flattened cardboard boxes.
- Place additional recycling bins in hallways, around lockers, and in classrooms to capture all recyclables.
- Place trash bins next to recycling bins to avoid contamination in the recycling bins.
- Empty recycling bins as frequently as needed.
- Make morning announcements reminding students and teachers to recycle.
- If your dumpsters are full, call Mr. John Meyer (240-277-3285) to request additional pick ups.
- Keep in mind that the scheduling of an extra pickup takes 24 hours. So don't wait until your dumpster is completely full!

- The GOT PAPER? contest is open to all MCPS elementary, middle, and high schools.
- The contest runs from June 1, 2018 through June 30, 2018.
- Only paper that has been properly recycled will be weighed and count toward your school's total.
- One elementary, middle, and high school with the greatest PPP will win.
- The winning schools will receive SERT awards in the following amounts:

\$1,000 high\$750 middle\$500 elementary

- Contest winners will be announced in August.
- Contest awards will be transferred directly into the building service supply accounts of the winning schools.

BATTERIES TRASH VS. RECYCLING

Toss in the trash—

• Dry cell and alkaline batteries, most often found in flash lights, toys, and appliances

Recycle-

- Lithium and lithium-ion batteries
- Nickel-cadmium batteries
- Uninterruptible power supplies (UPS), personal and network
- Tool batteries

• Rechargeable batteries
