

# Charge

- Gaithersburg Cluster Elementary School Capacity Study 2014-2015.
- Col. Zadok Magruder Cluster is adjacent and has available capacity or capacity can be added to existing schools.
- In November 21, 2016 the Board of Education authorized a boundary study process
  - consistent with MCPS Regulation FAA-RA to obtain viewpoints of affected stakeholders
  - possibility to reassign portions areas located east of I-370 in the Washington Grove Elementary School, Forest Oak MS, and Gaithersburg HS attendance areas to Col. Zadok Magruder Cluster Schools.








#### Vacant and Potentially Redevelopable Properties




From 2006 Sector Plan





## **Boundary Review Process**

#### **Three Phases:**

- Boundary Advisory Committee review
- Superintendent's recommendation
- Board of Education review, public hearing, and decision



# **Committee Process**

- Identify important community issues develop committee criteria
- Representatives evaluate boundary option using committee criteria
- PTA and other organizations represented on the boundary committee may submit position papers for committee report
- Feedback forms from community meetings



# **Board of Education Policy**

Board of Education Policy FAA – Long-range Educational Facilities Planning, lists four main factors to consider in developing school boundaries:

- Demographic characteristics of student population
- Geographic proximity of communities to schools
- Stability of school assignments over time
- Facility utilization

## **Phase 3: Board of Education Review**

- Work session in early November 2017
- Public hearing mid-November 2017
- Decision on boundaries by end of November 2017
- Boundary changes effective September 2018

- Does staff decide on boundary?
- Can I have the student data in the zones?
- Should I advise my child or update the principal?
