Dear Parents/Guardians,

Each school in Montgomery County is required to develop and enforce a local school discipline policy. The staff of Ashburton and a group of parents jointly developed this discipline policy and revised it as necessary. The Ashburton Discipline Policy is attached.

Please discuss the attached discipline policy as a family. Read and talk about it together. Review each inappropriate behavior and possible consequences. Explain how each problem will be solved and how each child is responsible for his/her OWN behavior. Let your child know that inappropriate behavior is not acceptable and that the home and the school will be working “together” on discipline. Your part in this endeavor is important. We appreciate your taking the time to follow through with the discussion as soon as this policy arrives home. Signed forms will be kept on file in the school office.

We at Ashburton will continue to insist upon sound discipline within our student body consistent with the rules of fair play. I hope that, if we find it necessary to contact you about your child’s behavior, you will understand that we always act in the best interest of all children and that you will support us.

Students may face disciplinary actions as a consequence of any behavior that disrupts classes, causes disorder, invades the rights of others, is unsafe or violates a school rule or disciplinary code. Consequences may be increased in cases of repeat offenses. The continuum of consequences will be determined by the administration. Out of school suspensions may only be given when it is determined by the principal that a behavior is disruptive and detrimental to the operation of school.

Some types of behaviors, such as making bomb threats, making threatening statements to students or staff regarding death or infliction of serious bodily harm/injury, possession of a firearm, or false activation of a fire alarm, result in significant consequences in terms of disciplinary actions and criminal sanctions. These types of infractions are included in the Montgomery County Public Schools’ policies and procedures for discipline. SCHOOL/CLASSROOM BEHAVIOR AND EXPECTATIONS:

Although most students do not have problems following appropriate expectations, these policies, procedures, and rules are included to help students clearly understand what is expected of them and the disciplinary steps that might be taken if rules are not followed. Please read the following expectations and discuss them with your child(ren).

Behavior in Halls

Students are to walk quietly in an orderly fashion through the halls at all times. This policy will be respected during the instructional school day and with consideration for others who are working.

Minimum: Staff/student conference, parent/guardian contact, and/or detention

Maximum: Detention

Behavior in Restrooms

Students are expected to respect the rights of others and act responsibly in restrooms. Any misuse of towels, toilet paper, soap, defacing of restroom facilities and the like, constitutes destruction of property.

Minimum: Loss of independent restroom privileges, and/or detention

Maximum: Suspension

Behavior in Lunchroom

The lunchroom should be a safe, comfortable, inviting, and clean environment where all interactions between students and adults are respectful. Students are expected to follow directions the first time they are given. They must talk quietly, stay seated unless given permission to walk around by an adult, keep their eating space clean, and practice good manners. For health reasons, children are not allowed to share food of any kind with others.

Minimum: Verbal warning, move to an assigned seat

Maximum: Exclusion from the lunchroom, suspension

Behavior on Playgrounds/Recess

The playground should be a safe, pleasant, friendly environment where all interactions between students and adults are respectful. Students are expected to follow directions the first time they are given. They must walk in an orderly fashion to the playground, use the equipment responsibly, show respect for others by using appropriate language and leave the playground only when permission is given by an adult.

Minimum: Verbal warning, isolation for a set period (time out), and/or detention

Maximum: Exclusion from playground, suspension

Behavior on Bus

The same standards of behavior that apply at school also pertain at the bus stop or while boarding, riding and unloading school busses. Students must respect the rights of others and must not pose a threat to anyone's safety. Students must not distract the bus driver.

Minimum: Staff/student conference, parent/guardian contact, and/or detention

Maximum: Exclusion from riding bus for a period of time, suspension

Behavior During School Sponsored Activities/Field Trips

Students are expected to conduct themselves in a respectful and responsible manner during school sponsored activities, programs and field trips. Behavioral expectations are consistent with school policies.

Minimum: Removal from activity, student conference, notification of parent, and/or detention

Maximum: Exclusion from future activities and/or suspension

Academic Dishonesty, Cheating or Plagiarism

This is defined as using the work of others as your own.

Consequence: Parent conference; no credit for the work

Acts of Hate /Violence

This is any act of hate/violence including, but not limited to, verbal abuse, slurs (including ethnic, religious, or gender based), threats, physical violence or conduct, vandalism or destruction of property directed against any person.

Minimum: Staff/student conference, and/or detention, parent/guardian conference, suspension and/or police referral

Maximum: Recommendation for expulsion and/or police referral

Computer Abuse

This is any misuse of the computer such as inappropriate use of websites, using another person's login, or to misrepresent one's work or oneself.

Minimum: Loss of privileges, restitution, student/parent conference

Maximum: Police referral, recommendation for expulsion, restitution

Destruction of Property/Vandalism

This includes breaking, damaging or defacing school or private property, or misuse of materials or equipment which results in damage to school or personal property. This includes graffiti.

Minimum: Restoration of property or value, parent conference, and/or suspension

Maximum: Recommendation for expulsion, restitution, police referral

Disruptive Classroom Behavior

Disruptive classroom behavior is any behavior that adversely impacts the learning of others.

Minimum: Removal from situation, office referral, notification of parent, and/or detention

Maximum: Suspension

Dress

School personnel may advise students about appropriate dress, footwear, and grooming for school, but they may not discipline students for their style of dress or grooming unless it:

- is likely to cause or causes a disruption to school activities, educational environment, (NO hats or heeilies);
- endangers health and safety;
- fails to meet a reasonable requirement of a course or activity, e.g., physical education class, outdoor education, specific field trips or day trips;
- is associated with gangs;
- is lewd, vulgar, obscene, revealing, or of a sexually provocative nature;
- promotes the use of drugs, tobacco, intoxicants or inhalants.

Minimum: Parent contact, removal of disruptive articles, and/or detention

Maximum: Suspension

Excessive Tardiness, Truancy, Leaving School Without Permission

Students must be on time for school and in their classrooms by 8:50 a.m. Missing the bus and oversleeping are not excused reasons for being late to school. Students are to remain on school grounds in their scheduled classroom locations unless written permission for early dismissal has been provided to the school by their parent/guardian.

Minimum: Parent/guardian phone conference, letter to parent from principal

Maximum: Parent/guardian conference at school, in-school suspension, referral to pupil personnel worker

Extortion

Extortion is an act of attempting to secure money, property, or favors through a threat or implied threat of physical or psychological harm.

Minimum: Parent/guardian conference and suspension

Maximum: Recommendation for expulsion

False Fire Alarm

False fire alarm is activating or causing the fire alarm to sound when there is no real evidence or sign of fire. Falsely reporting a fire endangers the safety of all.

Minimum: Administrator/student/parent conference, suspension

Maximum: Recommendation for expulsion, referral to Fire Marshall

Fighting/Physical Aggression

This includes play fighting, pushing, wrestling, hitting, shoving, kicking, slapping, spitting or throwing harmful objects, etc. involving two or more people. It is any form of physical confrontation.

Minimum: Staff/student conference, and/or detention, parent/guardian conference

Maximum: Suspension or recommendation for expulsion

Inappropriate Language/Gestures

This is the use of profanity, obscene language, or gestures, which are not acceptable in school or on the school grounds. All students and staff are entitled to an environment free from profane, hateful, racist, prejudiced or obscene language and gestures.

Minimum: Warning, time-out, staff/student conference, staff/parent conference and/or detention

Maximum: Suspension

Incendiary Devices/Fire setting

This is the possession of firecrackers, matches, lighters, caps, or any other thing which can start fires.

Minimum: Detention, suspension, notification to the Fire Marshall, confiscation of item, when appropriate

Maximum: Recommendation for expulsion

Insubordination/Disrespect

This is willingly refusing to obey a lawful request of any staff member. This includes repeatedly wearing hats in school, chewing gum, or bringing inappropriate items to school (all toys and games, to be returned only to an adult). This is also refusing to identify oneself.

Minimum: Warning, time-out, staff/student conference, staff/parent conference, referral to principal, detention

Maximum: Suspension

Malicious Pranks and Pseudo Threats

This includes any act or substance used to cause disruption, panic, or an unsafe situation, such as pulling a fire alarm or deliberately misrepresenting substances as something they are not.

Minimum: Staff/student conference, and/or detention, parent/guardian conference

Maximum: Suspension or recommendation for expulsion and/or police referral

Physical Attack on Staff or Fellow Student

This includes any aggressive physical battery on a staff member or person. This includes any physical contact (hitting, touching angrily, pushing, shoving, kicking, biting, etc.) in an aggressive manner with the intent to do harm.

Minimum: Staff/student conference, and/or detention, parent/guardian conference

Maximum: Suspension or recommendation for expulsion

Possession of Communication and Other Electronic Devices

Beepers, electronic paging devices, cellular phones or personal radio devices are not allowed. Laser pointers and other disruptive devices will be confiscated. Cell phones are only allowed with the principal's permission.

Minimum: Confiscation of device, suspension for repeated or extremely serious violations

Maximum: Recommendation for expulsion

Possession or Use of Destructive or Harmful Substances

This is possession of matches, tobacco products, smoke bombs, stink bombs, pepper spray, or any other destructive or harmful substance.

Minimum: Confiscation, parent notification and conference, suspension, fire marshal and/or police referral

Maximum: Recommendation for expulsion

Possession, Use, or Distribution of Illegal Drugs/Intoxicants/Inhalants/Smoking Materials

This is possession of intoxicants, inhalants, smoking materials or controlled substances which are prohibited.

Minimum: Confiscation of substance, administrator/student/parent conference, police notification and suspension

Maximum: Recommendation for expulsion

Sexual Harassment

Sexual harassment is defined as unwelcome advances, requests for sexual favors, and/or other inappropriate verbal, written, or physical conduct. (Refer to MCPS Policy ACF "Sexual Harassment" and MCPS Administrative Regulation ACF-RA "Sexual Harassment".)

Minimum: Confidential administrator/parent/student conference and/or suspension

Maximum: Recommendation for expulsion

Teasing, Verbal or Non-Verbal

This includes name-calling, put downs, making fun of the way someone talks or walks, making fun of someone's clothing or customs. Non-verbal examples include making faces, drawing inappropriate pictures, poking or pointing, and inappropriate hand gestures.

Minimum: Personal apology to the person who was teased AND a letter of apology to that student. The letter must be signed by the child's (teaser's) parent(s) and returned to school the next day. Additional consequences may include warning, time-out, staff/student conference, detention, parent conference.

Maximum: Suspension

Theft/Burglary

This is taking something which does not belong to you. Students must demonstrate a respect for the property of others. Any found articles must be returned to the office or the rightful owner.

Minimum: Parent/Guardian conference and full restitution

Maximum: Suspension and/or police involvement

Threats (verbal, electronic or written)

This includes any overt or implied verbal, electronic, written, or physical threats. Examples include, but are not limited to, telling someone that you will hurt him or her whether in jest or as a serious suggestion, any conversation or discussion where you suggest action that will cause physical harm to someone, suggesting property destruction..

Minimum: Conference

Maximum: Suspension or recommendation for expulsion

Weapons

This is unauthorized storing, possessing, or carrying firearms, knives, or any other object (including look-alike or pretend weapons) which could be used to cause bodily harm/injury as a weapon. This is a very serious offense and is strictly prohibited.

Minimum: Confiscation of weapon, parent/guardian conference, and suspension

Maximum: Police referral, recommendation for expulsion
