November 29, 2011 – National Building Museum (\$9)

April 19, 2012 – Tudor Place/Dumbarton House (\$10)

May 23, 2012 – Udvar-Hazy Air and Space Museum (\$20)

Please send a check made out to *North Chevy Chase Elementary School* for the lump sum of \$44. All permission slips should be turned in by September 30, 2011. If this option is not preferable, you may opt to pay for each field trip individually, but must pre-arrange to do so with your child's homeroom teacher.

Please remember to look for additional information regarding each field trip prior to the trip. We recommend that your child gets a good night of sleep, eats a balanced breakfast the morning of the trip, and comes prepared in the appropriate attire and walking shoes. Be sure to check the weather the day of the trip as some field trips will be outside.

Families who need a scholarship to help cover the cost of the trip will need to write a note to the principal, Ms. Stevens. Scholarship information is confidential.
