Re: Annual Report of the Title IX Advisory

Committee

Ms. Margaret Zierdt stated that their first objective was to maintain and update knowledge about Title IX law and how it relates specifically to the Montgomery County Public Schools. They recommended that the Board continue to monitor the employment situation. Their seconded recommendation was that the Department of Personnel Services should develop an action plan for increasing the number of females in A&S positions. Their third recommendation concerned the math/science and women Their survey showed a great discrepancy in the enrollment of young women in the more advanced areas of science and mathematics. Mrs. Zappone asked whether they had checked the grades students had achieved at the lower level because students pursued courses where they are successful. Ms. Zierdt explained that they had the data requested by the State Department of Education, but it would be interesting to find out the scores that boys and girls achieved. If there were differences, it would be a good place to start remediation. Greenblatt asked whether they had any theory as to why there were more women in advanced biology. Ms. Zierdt replied that it was one of the courses women had been permitted to pursue. noted that more girls took biology than physics. Mrs. Spencer remarked that this spoke to the counseling for course enrollment She pointed out that biology was useful for and for careers. someone going into a nursing career.

Dr. John Larson explained the appendices that he had developed. He said the higher level of the course, the higher percentage of male enrollment, and there was a trend of increasing male concentration in the higher mathematics courses. He felt that this was probably by student choice rather than what the schools did for or to them. He pointed out that the broader range of options the students had available, the more clearly the sex differences were seen. He noted the required courses were about 50/50.

Mrs. Spencer pointed out that the recommendations made by the committee were all administrative recommendations. In regard to the internship brochure, Mrs. Zappone wondered whether they should defer publishing because internships were limited. The superintendent explained that this recommendations was not in the real world because there were 60 less positions in the areas and they would be looking at the central office. If the closed 20 schools, they would have 20 less principals. Ms. Irma Dobkin felt that even with closings it would be better to have something in writing because it did make the commitment.

Mrs. Spencer called attention to the recommendations about the survey report. She cited staff training, improved counseling, improved public relations, and evaluation and follow up.

Ms. Zierdt called attention to the memorandum on pregnant students. She hoped that the school system would encourage pregnant women to staff in class and to return to class as well and encouraging the fathers to stay in school. Mrs. Zappone

asked about the numbers of students involved here. She said that when they had discussed this previously she had raised the question of having visited a New Horizons High School which had all the things needed by a teen family.

Dr. Greenblatt asked whether they had any indication that the school system was not doing the things that they recommended from the survey report. Ms. Zierdt replied that these were continuing concerns. She felt that they needed to be constantly aware of these concerns, but she said that the county could pride itself on where it was. She said the MCPS should conduct a survey to find out how much knowledge students had about Title IX. Mr. Ewing commented that he did not disagree with this recommendation, but what was not clear was what the school system should do when it found out what students knew about Title IX. Ms. Dobkin replied that part of this would involve an outreach program to the community.

Ms. Zierdt said they were recommending that MCPS analyze a sample of communications sent home to determine whether sex-fair language was used. One other item was continuing dialogue with Board members. She said they were pleased that the Title IX liaison people received training last year and would receive it this year. In regard to Merit Scholarships, they investigated the cost of having every junior take the PSAT and found it would cost \$54,000. In terms of community outreach, the committee had participated in the Women's Fair. In regard to the Merit Scholarships, Mr. Barse said the report stated that any inequity was a function of individual schools and was not system wide. It was not clear to him what happened in the individual schools.

Ms. Zierdt replied that they first thought that schools not responding to their survey had a low percentage of girls who achieved semi-final status, but they found it was not true. She called attention to the item on sex bias in tests and recommended that MCPS form a committee to examine test for sex bias. They also has the objective of working with students and had found that the students on their committee had been very helpful. They had found that the visibility of the Title IX people in the schools was low. Their fifth objective was to have more community participation, and they would be celebrating Women's Week on March 7-13, 1982.

Mrs. Spencer inquired as to whether the half-day human relations workshop would be an additional day or whether they would use one of the existing days. Dr. Stephen Lanham Tarason replied that the recommendation was to use the existing half-day. Mrs. Spencer thanked the committee for their presentation.
