Re: Monthly Financial Report

The superintendent explained that this month's report had a slightly different format which tried to simplify the information. In expenditures they were highlighting areas where they had surpluses of deficits. He said that Category 6 showed a difference because of four days of not running school buses. The basic difference was that the projected deficit had decreased. He indicated that they had a corrected utilities page.

Mr. Richard Fazakerley, associate superintendent for supportive services, said they were breaking out revenue and expenditures on They were trying to give the Board an idea of several pages. how well they were doing in forecasting. On utilities they were beginning now to have a much better report. Dr. Philip Rohr, director of the Division of Construction and Capital Projects, said they were showing expenditures as of December 31 and usage would be one month behind. The bills they received would reflect the use through that period. Also for the first time they were showing the utilities such as fuel oil, electricity, natural gas, and propane has. He felt that generally they were doing better than last year. They would also have a separate report they would use as a management tool as to what each school utilities las year, which they hoped would enable them to reduce the cost of utilities.

Mrs. Spencer asked that the superintendent say a few words on the employment freeze. The superintendent explained that they had not been as stringent on the freeze this year; however, they would be compiling salary lapse funds. He felt that they were better budgeted this year in terms of utilities; therefore the employment freeze was much less severe. Mr. Ewing thought that the new attachment 3 was very useful. It was his view that some of the narrative needed to be expanded, if not monthly, then quarterly. The superintendent indicated that in some cases the format simplified things too much, and in some cases footnotes were needed to explain such items as supported projects.

Mr. Lipson inquired about how utilities were controlled in the high schools. Dr. Rohr replied that they had computer controls at almost all the high schools and did have the ability centrally to turn the heat on and off; however, there was always a manual override at the school. Mr. Lipson asked about the number of schools having computer controls, and Dr. Rohr explained that 18 of the 22 high schools had them as well as three intermediate and three elementary schools. All secondary schools would be under controls in a year.

Re: Executive Session

The Board met in executive session on personnel matters from 10 p.m. to 10:15 p.m. Mr. Lipson left the meeting during the executive session to study for final examinations.

Re: Board Member Comments

- 1. Mrs. Wallace recalled that she had requested a legal opinion on IEPs as to whether MCPS was legally responsible once an IEP was signed. The superintendent indicated that they would have something by January 26. Mrs. Spencer explained that she had a memo supporting Mrs. Wallace's request and asking for information on the Stephen Knolls program.
- 2. Mrs. Wallace said that Mr. Barse's motion on Blair had a time limit of 45 days; however, they were past the deadline. The superintendent replied that he would have a paper for the Board later in the week.
- 3. Dr. Greenblatt reported that at the National School Boards Association meeting an effort was made to get someone from this area to be the northeast regional person; however, this did not work out. She felt that at the convention there might be discussion of this possibility.
- 4. Mrs. Spencer stated that the Federal Relations Network would be meeting on the Hill, and she would be attending along with Dr. Greenblatt and Mr. Fess. They would be hosting a breakfast for the Maryland Delegation.
- 5. Mr. Ewing said it was his understanding that the Board would be represented by its president at the Maryland Advisory Committee of the U.S. Civil Rights Commission. He asked whether Board members would by able to see her statement in advance. Mrs. Zappone explained that the statement was being formulated, and the superintendent added that they hoped to have it on January 26. Mrs. Spencer asked whether she would be presenting a Board position or speaking as an individual who happened to be president of the Board, and Mrs. Zappone indicated that it was the latter. She said that she would try to get the statement to everyone as soon as possible.
- 6. Mrs. Wallace commented that it was her understanding that Dr. Greenblatt was privy to certain things from the Green Street Coalition, and she hoped this material could be shared with other Board members. Dr. Greenblatt explained that she received this material because she was on the legislative committee of the Maryland Association of Boards of Education.
- 7. The superintendent reported that a number of decisions were made in the state superintendents' meeting. The expense aid budget as well as transportation was up 8 percent; however, aid to the handicapped was at FY 1982 dollars. He said that the state superintendent would be setting up a task force on secondary schools. The state superintendent had indicated that local boards of education could increase their graduation requirements. With respect to block grants, the state superintendent would not go along with the committee report. The report will recommend that the high cost

criteria would be the handicapped and Title I. The committee report would be presented at the state Board of Education meeting.

8. Mrs. Wallace recalled a discussion about awarding certificates of academic achievement. The state said there was nothing to prevent Montgomery County's having a separate certificate over and above the diploma; however, staff had advised the Board they could not do this. She asked the superintendent to find out whether they could, in fact, do this.

Continue in-service programs for staff in regular and regular and special and alternative education

IV. Improve school leadership and management

Develop a process for working with the Montgomery County Association of Administrative and Supervisory Personnel, and consult with this group about the principal selection and evaluation process

V. Adopt and seek funding of the FY 1983 Operating Budget

Improve educational services for children as a result of the savings realized from the school closure process

VI. Develop a process for the annual review of Board policies

Review all policies currently on the books and the new classification and publication system for policies and procedures, and rescind those policies that are no longer useful to the operation of the school system

Review the policy on student smoking on school grounds

VII. Increase measures to discourage student use of drugs and alcohol

Review the effectiveness of current policies

Expand preventive programs

Support the components of the new health curriculum related to drug and alcohol abuse

Increase efforts to help students develop responsibility and self-discipline

IX. Review the policy on long-range educational facilities planning

Make modifications to the policy, if needed

<u>Resolved</u>, That this list of priorities is not in any particular rank order; and be it further

<u>Resolved</u>, That the Board of Education priorities be widely distributed to staff and interested citizens.
