RESOLVED, That the Board of Education amend the FY 1983 operating budget by adding \$166,000 to Category 10 to increase the target level to no less than \$353,166,000.

Mr. Ewing said the record should show that in its view the action just adopted by the Board does not preclude it from seeking additional funding for the Blair High School academic improvements.
