BOE Hearing No. 1984-3
SCHOFER AND ALAN HANSEN
DECISION AND ORDER

This appeal involves the question of whether certain "personal advertisements" should be permitted to be included in the 1984 edition of the Walter Johnson High School yearbook. The Board of Education has reviewed the advertisements in question and has heard the arguments of counsel with respect thereto. The Board finds that the advertisements at issue are in poor taste and reflect and promote unlawful behavior. The Board further believes that the editors of the Walter Johnson High School yearbook, in the exercise of their editorial discretion, should decline to include such material in the 1984 edition. However, there appear to be sufficient questions as to the vagueness and legal sufficiency of

present guidelines governing the inclusion of advertisements in student publications that the Board of Education should not preclude inclusion of the advertisements at issue. The Board of Education strongly urges that the editors of the Walter Johnson High School yearbook reconsider their decision to include such advertisements.

For the foregoing reasons, the Board of Education does hereby most reluctantly reverse the decision of the deputy superintendent of schools, acting as the designee of the superintendent of schools, subject, however, to the following conditions:

- There shall be included at the beginning of the 1984 edition of the Walter Johnson High School yearbook a prominent statement that all advertising matter contained in the yearbook does not reflect the viewpoint or policies of the editors, Walter Johnson High School, or the Board of Education.
- 2. All advertisements included in the 1984 edition of the Walter Johnson High School yearbook shall contain a statement on the page of publication designating such advertisement as a "paid advertisement."
- 3. The staff is directed to review and promptly bring to the Board of Education for action revised guidelines for the overall content of yearbooks and other student publications, including advertisements contained therein. Such review shall include consideration of the desirability of continuing to allow personal advertisements to appear in student publications.
- 4. The staff is directed to promptly bring to the Board of Education for action a review of the objectives and content of the MCPS journalism curriculum.
