Re: **BOARD/SUPERINTENDENT COMMENTS**

Mr. Barclay commented on the Public Safety Boards that recognized the fire/rescue and police for their dedicated work in Montgomery County. Last Saturday, there was a groundbreaking for the Paint Branch High School facility, which was a time of excitement for the community. Finally, he attended an event called SMART, which is a program put together by Community Bridges working with young women to do problem solving in schools.

Ms. Brandman noted that the Board is continuing with cluster visits, and she thanked the Whitman and Richard Montgomery clusters. She was pleased with the clusters for hosting and opening the events to community members.

Dr. Docca enjoyed the cluster meetings, and she commented on the Student Leadership Training.

Ms. Berthiaume associated herself with her colleagues' remarks. Also, she reported on her volunteer time with the cafeteria at Rockville High School. She went on to comment on the food served to children in light of the reauthorization of the Child Nutrition Act.

Mr. Kauffman associated himself with his colleagues' remarks. Also, he congratulated Springbrook High School for its state championship in 4A Boys' Basketball and Seneca Valley High School for the Girls 3A Basketball championship.

Mr. Hwang commented on the Maryland legislative session, the two SMOB candidates, voter registration, and the 2010 census.

Dr. Weast congratulated the participants, coaches, and championships teams in this past winter sports season. Among a total of 41 award winners, there were five state or metropolitan champions, eight regional champions, and 28 division champions. Special kudos to our state and metro championship teams:

Dr. Weast continue and stated that on an evening when the Board will be discussing the important role of parents in the success of Montgomery County Public Schools, it is especially appropriate to recognize Montgomery County's winner of the Parent Involvement Matters Award. The award, sponsored by the Maryland State Department of Education and Comcast, recognizes a parent or legal guardian from each Maryland jurisdiction for exceptional support of public education. Parents are nominated for demonstrating significant, positive impact in their education communities. Congratulations to Mr. Earle Barnes, a parent at Shady Grove Middle School. Among his many contributions is founding and leading a mentoring group for at-risk male students called Students with Attainable Goals—SWAG for short.

Finally, Dr. Weast reported that the Ninth Annual Young Professionals Conference was held last week at the Universities at Shady Grove. More than 700 high school juniors enrolled in career pathway programs had the opportunity to experience a professional development conference designed especially for them. The program included breakout sessions guided by members of the business community designed to answer student questions about a range of careers. Thanks to the sponsors who joined us to present this great event: the Montgomery County Business Roundtable for Education, Montgomery College, and the Universities at Shady Grove.

Re: MCPS PARENT ACADEMY AND PARENT ADVISORY COUNCIL

Dr. Weast invited the following people to the table: Ms. Aggie Alvez, director, Office of Communications and Family Outreach; Mr. Eric A. Davis, director, Department of Family and Community Partnerships; Ms. Eugenia Dawson, principal, Earle B. Wood Middle School; Ms. Celia Serkin, executive director, Montgomery County Federation of Families for Children's Mental Health; Mrs. Kelly Eiskant, co-chair, Parent Advisory Council; Ms. Elisia George, co-chair, Parent Advisory Council; and Mr. Hugo Escobar, member, Parent Advisory Council.

Montgomery County Public Schools (MCPS) is committed to promoting meaningful family partnerships as an essential component to students' success. Through the MCPS strategic plan and its parent and community involvement policies, the Board of Education has affirmed its belief that parents who are fully engaged as partners and who can advocate strongly for their child's education play an important role in their child's success in school and in life. More than 30 years of research have shown that family engagement linked to learning leads to improved student achievement. This memorandum provides an update on the Parent Academy and the Parent Advisory Council—two programs coordinated by the Office of Communications and Family Outreach (OCFO) that are integral to the school system's efforts to increase student achievement and remove barriers to parent engagement.

In January 2007, the Middle School Reform Steering Committee recommended the creation of a Parent Academy to empower parents as effective partners in their children's education. Parents at the middle school level, as well as those with children in elementary and high school, said they needed information to help them understand the school system and strategies they could use to support their children's learning. The MCPS Parent Academy, launched by the Office of Communications and Family Outreach in fall 2007, provides parents with this information through a variety of free workshops offered throughout the school year.

Systemwide Parent Academy workshops, open to all MCPS parents, are held in schools and neighborhood locations throughout the county. Child care and foreign language interpretation services are provided at no charge. Parent Academy workshops also are conducted in response to requests by individual schools and community organizations. The yearly cost of \$3,000 to operate the Parent Academy includes stipends for staff who provide child care services and funds for supplies and materials. The workshops are presented by central office and school-based staff as well as by partners from community, government, and business organizations. To determine topics for systemwide workshops, OCFO staff meets with principals to discuss topics of interest to their school communities and clusters. In addition, workshops are developed that focus on school system programs and initiatives, such as the Seven Keys to College Readiness. Feedback collected at Parent Academy workshops also is used to select topics and refine presentations and materials. Recent workshop topics include Algebra for Parents, Basic Computer Skills, Financing a College Education, the Special Education Process, Helping Middle School Students Become Great Writers, and High School and Middle School Magnet Programs.

Information about the Parent Academy is communicated through a variety of media. The schedule of workshops is available in six languages—in print and on the MCPS website. It also is disseminated through *MCPS QuickNotes*, Twitter, the Montgomery County Council of Parent–Teacher Associations (MCCPTA) listserv, local media, and materials sent to public libraries, recreation centers, and other neighborhood locations. Individual schools communicate with parents about workshops through Connect-ED calls, newsletters, and listservs. Information is shared through person-to-person interactions by parent outreach staff in OCFO and in other MCPS offices. Parents can register for workshops online or by phone, fax, or U.S. mail.

The MCPS Parent Advisory Council (PAC), established in August 2007, works with the Office of Communications and Family Outreach to provide input on ways to improve communication and parent engagement at the district and local school levels. The Council also provides parent advocacy trainings and feedback on school system initiatives and programs. PAC members are active leaders in their respective school communities, formally and informally gathering input and supporting other parents in their advocacy efforts.

The Parent Advisory Council is composed of 30 parents, each of whom serves a two-year term, and is led by two co-chairs. Attachment B provides a list of current PAC members. Information about the PAC, including photos and biographies of the members and meeting notes, can be found on the DFCP website. PAC members are parents who have at least one child in the school system and reflect the diversity of the MCPS community. This diversity includes geographic location of residence, child's grade level, and areas of interest and experience related to MCPS programs and services (for example, special education, gifted and talented, and ESOL).

Re: **DISCUSSION**

On behalf of the Board, Mr. Barclay thanked staff for their presentation. He was interested in the work done in local schools to recruit parents. The PAC answered that during interaction with parents, they give them the resources and knowledge they need to be an advocate for their children. Plus, the web engenders questions which can be researched Board of Education Minutes

and answered. Wherever they meet parents, PAC encourages parents to attend PTA meetings to know about the local school, curriculum, and assessments.

Mr. Hwang asked about organic growth within the Parent Academy and PAC. Staff replied that they will be working on the parent leadership component to bring parents together to advocate for their children and focus on leadership skills. PAC replied that in many cultures, parents are not comfortable in the schools, based on their background. It is the focus of PAC to make these people before parents with the school system in order to help their children. Staff stated that they are striving to make the schools welcoming and develop an element of trust of the school system. The PAC was interested in making meetings available to parents, such as nights or weekends.

Ms. Brandman thanked the presenters for their passion and commitment, which resonates with parents. She asked them about recurring issues or themes and the best way to bring that information to the Board. The Board could benefit from learning about the issues that the Parent Academy and PAC are tackling. Staff explained that the information garnered from parents is shared with strategic planning teams and is an ongoing process.

RESOLUTION NO. 173(a)-10 Re: POLICY IED, GRADUATION REQUIREMENT

On motion of Mr. Hwang and seconded by Ms. Brandman, the following resolution was adopted unanimously by members present:

<u>Resolved</u>, That the Board of Education directs to Policy Committee to consider language in Policy IED to waive a four-year graduation requirement.

RESOLUTION NO. 174-10Re: **TENTATIVE ACTION ON POLICY IED,** FRAMEWORK AND STRUCTURE OF HIGH SCHOOL EDUCATION

On motion of the Policy Committee, the following resolution was adopt unanimously by members present:

WHEREAS, Policy IED, *Framework and Structure of High School Education*, sets forth guidelines to staff and community for the organization of high schools and the delivery of engaging instructional programs that set high expectations for student achievement for all students and prepare all students to complete high school equipped for success in postsecondary education and the world of work by providing an environment supportive of the academic, social, emotional, and physical development of adolescents and young adults; and

WHEREAS, The Board of Education Policy Committee has considered and recommended revisions to update Policy IED, *Framework and Structure of High School Education*; and

WHEREAS, The Montgomery County Board of Education has received the Policy Committee's recommendation; now therefore be it

<u>Resolved</u>, That the Board of Education take tentative action on Policy IED, *Framework and Structure of High School Education*; and be it further

<u>Resolved</u>, That Policy IED, *Framework and Structure of High School Education*, be sent out for public comment.

Framework and Structure of High School Education

A. PURPOSE

To affirm the Board of Education's (Board) commitment to providing a challenging and comprehensive high school program that meets and exceeds the graduation requirements of the state of Maryland and prepares all students for postsecondary education and the workplace.

To provide guidance to staff members and community for organization of high schools and delivery of instructional programs that set high expectations for academic achievement for all students in an environment supportive of the social, emotional, and physical development of adolescents and young adults.

B. ISSUE

High school preparation is critical to success in college. Montgomery County Public Schools (MCPS) expects all students to complete high school prepared for success in postsecondary education and the world of work. The high school program ensures success for every student through a rigorous, comprehensive curriculum; relevant opportunities for students to clarify interests, goals, and plans for the future; a qualified and committed staff and leadership; a collaborative and flexible organizational structure; a differentiated instructional program; extracurricular activities; and actively involved parent and community stakeholders.

C. POSITION

1. School Culture

High schools maintain consistently high expectations for all students to acquire and develop lifelong learning skills, explore and envision a successful future, and make connections to post-high school life.

- a) Staff members believe that all students can learn at high levels and expect and encourage students to achieve at their full potential.
- b) The high school community is committed to equity, values diversity, and works actively to remove barriers to achievement so that student success is not predictable by race or ethnicity.
- c) Through instructional practices and extracurricular activities, students learn interpersonal skills necessary for healthy social, emotional, and intellectual growth. The school environment encourages and provides multiple opportunities for every student to be known well by one or more adults in the school.
- d) School leaders promote positive relationships among students, staff, and community members within a safe school environment. School leaders communicate clear behavioral expectations to students and staff.
- e) Staff, families, and community members work together for student achievement.
 - (1) School staff facilitate communication with the community in the languages spoken in the community whenever feasible.
 - (2) School staff work with students and parents to emphasize the importance of regular student attendance as an essential component of a quality learning experience.
 - (3) School leaders recognize and celebrate achievements of students, staff, and the community.
 - (4) Staff, families, and community members provide resources and options for service and work-based learning, mentoring relationships, and career activities.
- f) High school staff members provide the support students and families need to understand post-high school options, preparations required, and assistance available, thereby connecting current studies with future endeavors. Staff members provide ongoing support as follows:
 - (1) Work with each student to plan a course of study and related activities that transitions the student into and through the high school years, and details the courses needed to meet

academic and personal goals. Students shall satisfactorily complete a program of study beyond Grade 8, as described in MCPS Regulation ISB-RA, *High School Graduation Requirements*.

(2) Encourage students to take rigorous courses that are relevant to their interests and prepare them to achieve their postsecondary goals.

2. CURRICULUM, INSTRUCTION, AND ASSESSMENT

The MCPS approach to curriculum, instruction, and assessment ensures a high level of challenge for all high school students and meets the unique needs of young adult learners.

- a) Curriculum
 - (1) The high school curriculum satisfies the graduation requirements of the Board and the Maryland State Department of Education (MSDE). The Board has the authority to specify requirements beyond minimum state requirements when it determines it is in the best interest of all students. MSDE requires 21 credits for graduation, of which 18 must be earned in specified courses. MCPS requires 22 credits, of which 19.5 must be earned in specified courses and an additional half credit in physical education, as further described in MCPS Regulation ISB-RA, *High School Graduation Requirements.*
 - (2) High school course curricula encompass state and national standards to establish learning goals. The program of studies prepares students for success in postsecondary education and work by providing a variety of learning experiences to challenge all students. Curriculum will be reviewed in a manner consistent with Board Policy IFA, *Curriculum*, and MCPS Regulation IFA-RA, *Curriculum*.
 - (3) Each high school provides a comprehensive program of studies. The Board ensures consistency of course offerings across high schools by approving certain essential courses as Category 1. The Board reviews curriculum for Category 1 courses and ensures adherence to systemwide assessment standards. All comprehensive high schools offer an appropriate

range of Category 1 courses to provide the opportunity for all students to earn MSDE and MCPS required graduation credits within four years.

- (4) The Board approves additional courses as Category 2. Category 2 courses are important for continuing, expanding, and enriching student understanding in a subject area. In addition, a Category 2 course may meet a graduation requirement. These courses will be offered when student interest, staffing, and budget permit.
- (5) All Category 1 and 2 courses are listed and described in the MCPS *High School Course Bulletin*.
- (6) Students may apply credits earned for coursework at institutions other than MCPS when planned and approved in accordance with conditions described in MCPS Regulation ISB-RA, *High School Graduation Requirements*.
- b) Instruction

Instructional practices will incorporate a variety of methods, strategies, and resources that encourage students to be active and engaged learners.

- (1) Instructional practices align with relevant Board policies and MCPS regulations such as Board Policy IKA, Grading and Reporting; Board Policy IOA, Gifted and Talented Education; Board Policy IOD, Education of English Language Learners; Board Policy IOB, Education of Students with Disabilities; and MCPS Regulation IHB-RA, School Academic Grouping Practices.
- (2) High school instruction prepares students to comprehend, gather, evaluate, and synthesize information and collaborate with others to solve problems. Staff members prepare students as follows:
 - (a) Communicate high expectations for student achievement and success.
 - (b) Incorporate a variety of methods, strategies, and resources that evoke critical thinking and encourage

students to be active, engaged, and lifelong learners.

- (c) Use allocated instructional time efficiently and effectively.
- (d) Provide leadership opportunities for students as well as promote student discourse and effective self-expression.
- (e) Help each student meet his or her academic potential by providing differentiated instructional opportunities and resources as appropriate, such as acceleration, enrichment, support, and accommodations.
- (f) Utilize the special skills of all general, alternative, English for Speakers of Other Languages (ESOL), and special education staff members, in both the planning and implementation of instruction.
- c) Assessment

Assessment, as set forth in Board Policy IKA, *Grading and Reporting,* is an integral part of the instructional cycle. A comprehensive assessment program, aligned with district, state, and national standards, includes the following:

- (1) Grading criteria that communicate expectations to students and parents in a clear and timely manner.
- (2) Preassessments, formative assessments, and summative assessments, which are used to plan and deliver instruction to meet learning goals, provide meaningful and timely feedback to students on their performance, and offer varied opportunities for students to demonstrate learning.
- (3) Reteaching and reassessment within the instructional cycle to promote effective teaching and learning.
- (4) Ongoing and timely reporting of student achievement to students, parents, teachers, administrators, and the school system.
- (5) Consistency within and among schools.

3. Organizational Structure

MCPS administrators collaborate with school leadership teams, staff, parents, students, and the community regarding the organizational structure of their school and improvement plans, consistent with the priorities of the school system. Schools promote and maintain high achievement by employing a variety of structures for teaching and learning.

- a) High school leaders employ flexible scheduling and maximize their resources to provide active and meaningful learning experiences that foster student achievement, ease student transitions, and facilitate program continuity.
- b) High school leaders develop learning communities within the school that foster student achievement, respond to student interests, and promote positive engagement among students and staff.
- c) Each school is staffed and organized to ensure appropriate educational opportunities for students with a variety of educational needs.
- d) High school leaders provide opportunities for teachers to use time effectively and efficiently to achieve the following:
 - (1) Plan and coordinate instructional delivery and assessment.

(2) Monitor individual student progress, meet with students, and communicate with parents.

(3) Engage in professional learning communities and other professional development opportunities.

- e) High school staff use instructional time during the student day effectively.
- f) High school staff provides opportunities for enrichment and academic support through before-school and after-school extended learning and extracurricular activities.
- g) High school staff effectively use communication tools to promote professional learning communities and facilitate productive interactions among students, teachers, parents, and other community

stakeholders.

4. Leadership and Planning

MCPS administrators and school leadership teams collaborate with staff, students, parents, and the community to create, guides, manages, and inspires an effective learning community to ensure achievement by all students. Effective school leaders:

- a) Model the standards of the professional growth system for administrators, teachers, and supporting service personnel.
- b) Guide and monitor the implementation of a rigorous instructional program that sets the course to eliminate the achievement gap among students and is designed to prepare them to be college and career ready.
- c) Facilitate continuous improvement and implementation of the Malcolm Baldrige Education Criteria for Performance Excellence.
- d) Collaborate with staff, students, parents, the community, and other stakeholders to develop and articulate a shared vision of the academic and individual needs of students, the direction for the school, and progress toward stated goals.
- e) Develop leadership in the school and empower the staff, students, parents, and the community in the decision-making process.
- f) Manage the organization, operations, and resources for a safe, efficient, and effective learning environment.
- 5. Parent and Community Engagement and Communication

Consistent with Board Policy ABA, *Community Involvement,* and Board Policy ABC, *Parental Involvement,* school staff, parents, and the community are partners in the social and intellectual development of students. Elements of this partnership include the following:

a) Communication between families and school staff to provide information and solicit input and feedback regarding an individual student's educational experience, collaboration to support student learning outside of school, as well as opportunities for families to be involved in school and community activities and events.

- b) Parent, student, and community participation in school improvement teams and other advisory groups that set direction for the school, consistent with Board Policy AEB, *Strategic Planning for Continuous Improvement*.
- c) Collaboration with parent/teacher/student organizations, the community, businesses, and institutions of higher learning to bring outside resources to the school, make direct links between learning and careers, and provide authentic opportunities for student engagement.
- d) Parent advocacy and ongoing communication about MCPS policies, regulations, and practices.
- 6. Human Resources and Professional Development

MCPS recruits, employs, and retains high school staff members who possess the knowledge and skills to foster achievement and meet the needs of all high school students. The MCPS professional growth systems provide regular and systematic opportunities for all administrators, teachers, and supporting services professionals to increase their knowledge, skills, and capacity to continuously improve the teaching and learning process.

- a) Staff members are knowledgeable about the developmental characteristics of adolescents and communicate high expectations for all students.
- b) Staff members are skilled at developing positive relationships with students and parents and engaging them in the learning process.
- c) Staff members demonstrate content expertise and provide effective instruction.
- d) Staff demographics reflect, to the extent possible, the diverse population of MCPS.
- e) Staff selection considers the individual needs of each school.
- f) Staff members participate in the MCPS professional growth systems, which include regular and systematic opportunities for all administrators, teachers, and supporting services professionals to increase their knowledge, skills, and capacity to continuously improve

the teaching and learning process.

D. DESIRED OUTCOMES

- 1. An educational program that emphasizes academic excellence.
- 2. A comprehensive program accessible to all students that allows students to meet graduation requirements and to explore interests through elective courses and extracurricular activities.
- 3. Programs, courses, activities, and learning experiences that prepare students to be successful in postsecondary education and the world of work.
- 4. Collaboration among students, staff, parents, and families to support and encourage academic achievement and the intellectual, social, emotional, and physical growth of students.
- 5. A culture that fosters intellectual development and a sense of belonging, and promotes citizenship, responsibility, and mutual respect among students.
- 6. Graduates equipped to gather and use information and collaborate with others to solve problems and make informed judgments on public and private concerns.

E. REVIEW AND REPORTING

This policy will be reviewed in accordance with the Board of Education policy review process.

<u>Resolved</u>, That the Board of Education of Montgomery County conduct closed sessions on Thursday, April 15, 2010, in Room 120 of the Carver Educational Services Center to meet from 9:00 to 10:00 a.m. and 1:00 to 2:00 p.m. to discuss personnel matters, as permitted under Section 10-508(a)(1) of the *State Government Article*; consult with counsel to obtain legal advice while the Board reviews and adjudicates appeals in its quasi-judicial capacity;

and to discuss matters of an executive function outside the purview of the Open Meetings Act (Section 10-508(a) of the *State Government Article*); and be it further

Re: **NEW BUSINESS**

There was no new business.

Re: DISCUSSION OF THE MAINTENANCE OF EFFORT WAIVER RESOLUTION

Dr. Weast introduced the resolution, pointing out that the financial situation in the county did not allow it to meet the Maintenance of Effort (MOE) in the county executive's budget. Simply put, MOE are the funds for the proposed budget are based on the amount funded in the current year on a per pupil basis. The proposal would result in \$1,000 less per student. Therefore, it is necessary to request a waiver of MOE jointly with county executive and county. At this point, he read the resolution.

Mr. Barclay commented that these are extremely difficult times, and it is important for the Board to state categorically that reducing the budget by \$137.7 million from the school system's budget is the limit to the extreme. It is important to make this statement, and the three points in the resolution are important to be understood. He wanted people to know why he supports the budget and will fight vigorously to ensure that the reductions are not greater than \$137.7 million.

Mr. Kauffman stated that he supported the resolution as well. The Board knew that this day would come when the MOE budget requested was made to the county. The fiscal situation was one in which there would ultimately be reductions. He thought the Board made it clear to the community that it would have to agree to a waiver request to Maryland State Board of Education (MSBOE). He thought it is the right thing to do. Mr. Kauffman appreciated the county executive's difficult balancing of reductions to the Montgomery County Government and the revenue enhancements proposed. The Board should be supportive of him and the amount that is being recommended for the school system, even though there is pain in this recommendation. Last year, the school system learned a lot about MOE; it is an interesting law and not relevant during prosperous times. However, when times are bleak, there is a need for exceptions to the law. The Board is not in the same position as last year. When the waiver was denied last year, the school system will hope for the best, but this time it will plan for what might happen. The Board cannot be put in same situation with a penalty or fine. The Board needs to make it clear to the county executive and County Council that

the Board cannot tolerate the situation where it faces another fine or seek legislative relief.

Ms. Brandman echoed the comments of her colleagues. It is critical to explain that this is not a decision the Board comes to quickly or lightly. Last year was the first time anyone had ever requested a waiver of MOE. Under current law, the county would have to make an application to MSBOE by March 31 and the school systems position needs to be on record by April 10. Moving forward is because the deadline is upon the county and school system. It is a testimony to the fact that these are truly devastating fiscal times. In a county that clearly values education, the crisis is of a magnitude that warrants trying to find a solution that will avoid making the problem worse by triggering a penalty. She supported the application in recognition that there are few options. As the Board has spoken with elected officials, there has been recognition that a perverse aspect of this law is that the penalty comes back to the school system's budget since the county is the funding body.

Ms. Berthiaume associated her remarks with her colleagues. She thanked the county executive for his recommended operating budget in a very difficult time. She said he has shown true leadership in a tough time since his priorities are straight. It is not an easy reduction for the school system, but there also is pain on the other side of the budget as well. When it comes to education, children do not get a second chance. She echoed Mr. Kauffman's remarks about needing a plan and encouraging Board officers to listen, collaborate, and express the Board's views in the event that the MSBOE denies the waiver request.

Mrs. O'Neill stated that she appreciated the comments of the Board. Last year, many believed it was a one-time waiver request. It is apparent to her that this request for FY2011 is number two, and there maybe more problems looming in FY 2012. The school system cannot take any more reductions and a penalty would be devastating. The school system cannot rely on legislature again for relief of a penalty. Also looming on the horizon for FY 2012 could be local funding of teacher pensions. That will create a very difficult storm for the school system when county resources are diminishing and enrollment is rising. The Board will advocate for funding at County Council, and she looked forward to her colleagues joining her when she testified in April. All Board members need to advocate for holding the line—not one penny more taken from the school system since the children need to be educated now.

RESOLUTION NO. 178-10Re: MAINTENANCE OF EFFORT WAIVER

On recommendation of the superintendent and on motion of Mr. Barclay seconded by Mr. Kauffman, the following resolution was adopted unanimously by members present:

WHEREAS, Montgomery County intends to request a waiver totaling \$138,848,943 of the Maintenance of Effort requirement of a local contribution of \$1,553,934,287 (\$11,249 per student), pursuant to Section 5-202 (d) (7) of the Annotated Code of Maryland, Education

Article, because the county's fiscal condition prevents it from funding the Maintenance of Effort requirement without seriously impairing other county services; and

WHEREAS, Pursuant to Maryland State Board of Education procedures, the Montgomery County Board of Education must state its position on the county's waiver request no later than April 10, 2010; and

WHEREAS, Montgomery County Public Schools staff has received information about the county's fiscal condition and has worked closely with county staff to review economic and revenue data; and

WHEREAS, The county executive's Recommended FY 2011 Operating Budget requires the Board of Education to make \$137.7 million in nonrecommended reductions in its FY 2011 Operating Budget Request; and

WHEREAS, No further reductions can be made without seriously endangering the quality of education for Montgomery County Public Schools students; now therefore be it

<u>Resolved</u>, That the Board of Education supports the Montgomery County request for a waiver of the Maintenance of Effort requirements for FY 2011, if the following conditions are agreed to by the county executive and the County Council and are included in the action of the Maryland State Board of Education:

- The operating budget amount of \$1,940,540,941 in tax-supported resources (excluding grants and enterprise funds) recommended by the county executive on March 15, 2010, is fully funded by the County Council. This amount necessitates \$137.7 million in nonrecommended reductions in the Board of Education's Operating Budget Request.
- 2. The FY 2011 appropriation does not include any transfers of functions or expenditures from the County Government budget to the Board of Education budget unless the amount of the transfer is added to the amount recommended by the county executive.
- 3. The Maintenance of Effort requirement for FY 2012 will be based on the FY 2010 level of \$11,249 per student, unless subsequent action of the General Assembly changes the amount of the FY 2012 requirement by law; and be it further

<u>Resolved</u>, That the president of the Board of Education be authorized to submit this resolution to the Maryland State Board of Education and to represent the Board of Education at a public hearing on the county's waiver request; and be it further

<u>Resolved</u>, That a copy of this resolution be sent to the county executive and the County

Board of Education Minutes
