Re: STATEMENT BY DR. DOCCA

I thank my fellow candidates for sharing their supporters and the information about events, which were very helpful during the campaign. It has been wonderful to work with them, and I am glad that they are back.

As everyone knows, we are embarking on a search for a superintendent who will carry on in a determined, focused, and forceful tradition of Dr. Jerry Weast in providing excellent programs, qualified staff members, and the many academic choices and opportunities which have made MCPS an excellent school system. We meet the needs of most, if not all, students. The accomplishments by staff members and Dr. Weast include the highest graduation rate among the 50 largest and most diverse school systems in the nation. The highest SAT scores overall in the state and the nation. The highest percentage of students taking at least one Advanced Placement course. MCPS has more International Baccalaureate programs than any other school system in the state and the nation. MCPS outscores the state and the nation in African American and Hispanic students scoring 3 or better on the Advanced Placement exams. MCPS was the runner-up for the Eli and Edith Broad Award for Academic Achievement for diverse and large school systems. Last week, MCPS did win the coveted Baldrige Award; only one of six school systems in the nation to do so, as well as the largest and most diverse school system.

I cannot leave out our spectacular staff who caused us to be able to receive these accolades, but they have continued to labor even harder under the economic conditions under which we find ourselves. They have given up their COLAs for two years in a row on their own volition, recognizing the dire needs of the state and local economy. They did all of this despite the fact that enrollment increased by 6,200 and this year—2,200 more students not projected for enrollment. These addition students are receiving excellent services despite the fact that we are operating at a financial deficit.

I will continue to be dedicated to excellent programs for students and financial need for students in special education populations who deserve our enlightened programming. I strongly support our programs that require academic and intellectual growth—the magnets, the language immersions programs, International Baccalaureate, communication programs, the career and technology programs. We must continue meet the needs of all students who are sent to us to the best of our ability. We will continue to work cooperatively with state and local elected officials, but with the goal of the best we can secure for our students. If MCPS falters, the future of the county is in jeopardy because the schools have been a draw for residents and businesses to locate here in the best, most diverse, and progressive county in the United States."

"Tonight, I am both honored and humbled. I am grateful for the confidence you have shown in entrusting me with this important responsibility for four more years. My experience over the past four years has only heightened my sense of obligation to all our students. It is with sincere passion and dedication that I reaffirm my commitment to the fight for equity and excellence for all.

These are interesting times. In the midst of a national debate about education reform that often questions the effectiveness of public education, we at MCPS are seeing rays of hope and success. With an incredibly diverse student body that reflects the challenges and opportunities of school district with suburban, urban and rural areas, we are working with increasing effectiveness on simultaneously closing the achievement gap and raising the bar for all. We have been recognized by the Broad Foundation as well as the Baldrige National Quality Award. It is the talent and dedication of our teachers, principals, administrators, and support staff that has made our achievement soar. And yet difficult times continue to require more from them.

I am grateful for the chance to continue the unfinished business because we have not met our goals in all areas. To fulfill our promise we must redouble our efforts for students of color, limited English speakers, and special education students.

We face great challenges. After 12 years of stability and success under Dr. Weast's able leadership, we must transition to a new superintendent. The fiscal realities are daunting and will force us to confront limitations on our resources and to make difficult choices among worthy competing priorities. What we cannot afford to do is to lower our expectations or lose faith in our ability to reach all students. As some of you know, I am a first generation American whose immigrant parents came to the United States and relied on the public schools of New York to give me opportunity. My unshakable faith in public education is very

deep and very personal: that public school can be a stepping stone for all children, as it was for me. It is with great pride and enormous humility that I resume my place on this Board of Education eager to dedicate my skills and energy to serving our students.

I believe strongly that to be effective, a Board member must be grounded in the community and continue to reach out and listen. Campaigns are wonderful opportunities to participate in additional community conversations and hear community members' concerns. I want to continue to have my decision-making informed by your input, and for that I ask you to continue to be my partners.

It also requires collaboration and a good faith partnership among the players involved. I am fortunate to serve with talented and dedicated fellow members of this Board. We each bring a unique perspective to this work, and it is our task to listen and learn from each other so that we can make the best decisions on behalf of the students of MCPS.
