
Dear Parent/Guardian,

Each year under the Impact Aid grant, the federal government appropriates a certain amount of funding to support local school districts like MCPS that are located in federally impacted areas that educate federally-connected students (those whose parents/guardians work on federal property in Maryland, live on federal property, military housing, or housing project in Maryland, and/or US active duty uniformed services personnel or active duty foreign military) to help compensate for lost property tax revenue. The information collected from the Federal Impact Aid Survey is used to qualify for funding. The funding from the program becomes a part of the general operating budget that maintains our schools and enriches student programs.

Please note:

- **A separate survey is needed for each student. (Spanish version is available at link below.)**
- **2 employment addresses are required**—(1) the work location address and (2) the MD Federal property address for your agency (may be the same.)
- **Date and signature are required.**
