Guidelines for Incidents of Alcohol, Cannabis, Tobacco, and Other Drug Use Involving Students

I. PURPOSE

To establish procedures for incidents of alcohol, cannabis, tobacco, and other drug use or smoking involving students

II. DEFINITIONS

- A. *Drug* is defined in Maryland law as a controlled dangerous substance that is regulated under the *Maryland Controlled Dangerous Substances Act*, a prescription medication, or a chemical substance when used for unintended and harmful purposes.
- B. A Montgomery County Public Schools (MCPS) *property* means any school or other facility, including grounds owned or operated by MCPS, MCPS buses and other MCPS vehicles, and the facility and/or grounds of any MCPS-sponsored activity involving students.
- C. *Smoking* means to use or carry any lighted cigar, cigarette, pipe, or other tobacco product of any kind. This includes devices of any kind that simulate smoking.

III. PROCEDURES

A. Prohibited Student Uses

- 1. Students, including students 21 and over, are prohibited from using products on MCPS property that may not be consumed legally in Maryland by individuals under the age of 21. This includes, but is not limited to
 - a) alcohol,
 - b) tobacco (including electronic smoking devices and liquids used in them, regardless of nicotine content, and including accessories and components); and
 - c) cannabis, cannabis concentrate, cannabis products, or cannabisinfused products, as defined in Maryland law.
- 2. With certain exemptions, specified in MCPS Regulation JPC-RA, *Administration of Medication to Students*, students are prohibited from selfcarrying medications. Under no circumstances are students permitted to self-carry cannabis for medical use or medications that are controlled substances, including stimulant medications for attentiondeficit/hyperactivity disorder.
- 3. As set forth in MCPS Regulation JPD-RC, *Emergency Care for Individuals Experiencing Symptoms of Opioid Overdose*, students who carry naloxone on MCPS property and during school-sponsored activities are not subject to disciplinary action solely for carrying naloxone. When students observe a suspected opioid overdose, they are strongly encouraged to seek the assistance of DHHS or MCPS personnel, and/or contact 911.
- B. Communication

At the beginning of the school year, students and parents/guardians will be informed in writing of Montgomery County Board of Education policies, MCPS regulations, and pertinent laws designed to create a smoke-free environment for teaching, learning, and working that is free of alcohol, cannabis, tobacco, and other drugs.

- C. Identification and Assistance
 - 1. If, in the judgment of the student's teacher, a student is exhibiting healthrelated symptoms or acting erratically such that they are incapable of functioning properly in class, that student is sent to the school health facility where school health referral procedures are followed and the principal is notified.

- 2. State law affords certain protections to a student who seeks information or counseling on how to overcome substance-use problems from a teacher, counselor, principal, or other professional educator. Information received or observations made during such a counseling or student information session are kept confidential and are not admissible in any proceeding.
- 3. The student should be encouraged, at the earliest appropriate time, to seek help from their parents/guardians. The decision to involve parents/ guardians should be arrived at jointly by the student and educator, unless, in the judgment of the educator, the mental or physical health of the student is immediately and dangerously threatened by substance use. If such danger is imminent, the principal, parents and/or guardians, and school community health nurse/technician should be notified so that appropriate medical action may be taken.
- D. Reporting
 - 1. All incidents concerning possession, use, or distribution of alcohol, cannabis, tobacco, or other drugs or smoking on MCPS property are reported to the principal/director or designee.
 - 2. If the principal/director or designee has reasonable cause to suspect there may be a violation of the law, it is considered a serious incident, and they should follow protocols set forth in MCPS Regulation COB-RA, *Incident Reporting*, for notifying parents/guardians, appropriate MCPS offices, law enforcement or emergency services; reporting the incident; and releasing information, as appropriate.
- E. Handling Suspicious Materials

MCPS employees are reminded to consult with the Office of Systemwide Safety and Emergency Management (OSSEM) and/or MCPS Regulation JGB-RA, *Search and Seizure*, with any questions regarding search of student possessions. If an MCPS employee comes into possession of a substance they suspect to be alcohol, cannabis, or another drug, the material is handled in the following manner:

- 1. Using appropriate safety procedures, as outlined by OSSEM, the substance is placed in an envelope or otherwise contained and sealed.
- 2. The date, time, and nature of how it was obtained is indicated on the container. However, if the material was acquired from a student during a drug counseling or information-seeking conference, the name of the student from whom the suspected drug was received is not noted.

- 3. The suspected substances is turned over to the principal/director or designee who will follow procedures set forth in the MOU-CEO and MCPS Regulation COB-RA, *Incident Reporting*. The MOU-CEO establishes that law enforcement may take the lead in investigating –
 - (1) distribution or manufacture of, or
 - (2) possession of, or
 - (3) possession with the intent to distribute a controlled dangerous substance.
- 4. Student possession of a substance that poses a serious threat to the safety of the school, or possession of a sufficient quantity reasonably to indicate more than personal use, may be considered cause for elevating the disciplinary response indicated for possession in the *Student Code of Conduct in MCPS*.

To determine whether the substance poses a serious threat to the safety of the school, or is in a sufficient quantity reasonably to indicate more than personal use, the superintendent of schools/designee may consult with appropriate subject-matter experts (who may include external experts).

- F. Consequences
 - 1. Students who possess, use, or distribute, alcohol, cannabis, tobacco, or other drugs on MCPS property shall be disciplined in accordance with the *Student Code of Conduct in MCPS*.
 - 2. As a condition for participating in extracurricular activities or accepting leadership positions in school-sponsored groups, a student may be required to agree to additional restrictions and consequences for alcohol, cannabis, tobacco, or other substance use on locations other than MCPS property.
