For example, students who qualify for special services such as the Learning and Academic Disabilities (LAD) program may have two other designated schools identified because those schools offer an equivalent special education program. No obstante, ciertos servicios requeridos por el Plan Individualizado de Educación (IEP) pueden no estar disponibles en cada una de las escuelas designadas. Por ejemplo, los estudiantes que califiquen para servicios especiales como la clase de Learning and Academic Disabilities (LAD) pueden tener identificadas dos otras escuelas designadas porque esas escuelas ofrecen un programa equivalente de educación especial.
