RESOLUTION NO. 334-80 Re: REEMPLOYMENT OF LEGISLATIVE AIDE

On recommendation of the superintendent and on motion of Mr. Ewing seconded by Mrs. Spencer, the following resolution was adopted unanimously:

WHEREAS, The Maryland General Assembly has and regularly exercises the authority to enact laws that control the organization, financing, and other aspects of public education at both state and local levels; and

WHEREAS, It is vitally important for the Board of Education and superintendent of schools to be aware of and knowledgeable about legislative proposals, and to offer viewpoints on these matters to the legislators from Montgomery County so that the best interests of the public schools and their students may be served; and

On recommendation of the superintendent and on motion of Mrs. Spencer seconded by Mr. Paul, the following resolution was adopted unanimously:

WHEREAS, The Montgomery County Board of Education, as part of the reorganization plan for the school system, established the Office of Supportive Services on July 1, 1978; and

WHEREAS, The associate superintendent for supportive services is currently responsible for

school facilities, financial services, school services, management information and computer services, and personnel services; and

WHEREAS, The responsibilities of this office are too broad; and

WHEREAS, The Department of Personnel Services has school systemwide functions similar to the Departments of Educational Accountability, Information, and Human Relations; now therefore be it

<u>Resolved</u>, That effective July 1, 1980, the Department of Personnel Services will be responsible directly to the superintendent of schools, through the executive assistant to the superintendent.

Re: DISCUSSION WITH MEMBERS OF THE MEDICAL SOCIETY REGARDING THE MEDICAL ADVISORY COMMITTEE

Dr. Shaw pointed out that this was a discussion item. He reported that the Medical Society had approached him and the superintendent about concerns about the Medical Advisory Committee. Dr. Anne Mattern explained that the executive board of the Medical Society had approved a motion that the Medical Advisory Committee should consist of no more than ten members of the School Health Committee of the Montgomery County Medical Society and at least two of these physicians should be Health Department physicians. She said when they dealt with the trampoline issue they found out that the lay people on the committee could have out-voted the medical people.

Dr. Brett Lazar, Montgomery County Health Department, stated that they saw merit to the current set-up, but there had been a concern within the Department that the advice of physicians could not get through to the Board. Therefore, they supported the proposal. Dr. Mattern explained that there would be no objective to having observers at their meetings such as a representative from the Health Systems Planning Board.

Mrs. Spencer pointed out that this year's committee had six representatives from the Medical Society, two from the Dental Society, and four from the Health Department. She asked whether dentists were members of the Medical Society. Dr. Mattern replied that they only had one dentist who was a member. Mrs. Wallace felt there were certain specialists such as the general practitioner, the orthodontist, and the oral surgeon that they really needed to hear from. Dr. Mattern said that they had a child psychiatrist, a pediatrician, an adolescent pediatrician, and a doctor specializing in pediatric neurosurgery. Mrs. Wallace explained that she was thinking more in terms of orthopedics and dermatology as specialists that most parents used. Dr. Mattern agreed that they could list the specialties of the members of the committee.

Mr. Paul pointed out that the Board's committee was not there for medical advice but how to administer health services in the school system. Mr. Barse suggested that the Medical

Society's proposal should be brought to the Board for action and discussion at another time. He expressed his appreciation to the Medical Society for bringing the proposal to the Board and indicated that at the proper time he would propose this as a new business item.

Mr. Ewing stated that as with several of their other committees they had not consulted very frequently with the Medical Advisory Committee. He said that he appreciated their bringing this proposal to the attention of the Board. He suggested that when they returned to this subject that other groups be invited to join the discussion. Dr. Shaw agreed that the Board did need to consider the proposal and indicated that he would schedule this on a future agenda.
