Operating Budget

Division of Transportation

On recommendation of the superintendent and on motion of Mrs. Shannon seconded by Mr. Ewing, the following resolution was adopted unanimously:

<u>Resolved</u>, That the superintendent's FY 1985 Operating Budget be amended to add \$138,730 (3 FTE Bus Operators, 3.4 FTE Bus Attendants, and 2 buses) for transportation for special and alternative education, Division of Transportation.

A substitute motion by Mrs. Peyser to amend the FY 1985 Operating Budget by adding 87.8 teachers to reduce maximum class sizes in English to 25 and to 28 in other academic subjects, Senior High Schools, failed for lack of a second.
