RESOLUTION NO. 473-91 Re: BOARD AGENDA - MAY 29, 1991

RESOLVED, That the Board of Education approve its agenda for May 29, 1991.

RESOLUTION NO. 474-91 Re: FY 92 ADULT EDUCATION FEES

On recommendation of the superintendent and on motion of Mrs. Fanconi seconded by Ms. Gutierrez, the following resolution was adopted unanimously#:

WHEREAS, As a result of County Council action on the FY 92 Operating Budget, \$1,399,932 was moved into an enterprise fund for adult education programs; and

WHEREAS, This enterprise fund must generate revenue to make the programs self-supporting; and

WHEREAS, The Board of Education will need additional time to consider whether tuition waivers for senior citizens should be continued; now therefore be it

RESOLVED, That the Board of Education establish an Adult Education/Summer School Enterprise Fund; and be it further

RESOLVED, That the Board of Education set adult education fees for FY 92 at \$42 for a 7-week course and \$84 for a 14-week course; and be it further

RESOLVED, That the senior citizen tuition waivers will be continued during the 1991 summer session; and be it further

RESOLVED, That this summer the Board will consider whether tuition waivers for senior citizens should be continued.

RESOLUTION NO. 475-91 Re: FY 92 SUMMER SCHOOL FEES

On recommendation of the superintendent and on motion of Ms. Fanconi seconded by Mr. Chang, the following resolution was adopted unanimously#:

WHEREAS, As a result of County Council action on the FY 92 Operating Budget, \$300,000 was moved into an enterprise fund for summer school programs; and

WHEREAS, This enterprise fund must generate revenue to make the programs self-supporting; and

WHEREAS, The County Council also reduced the Board's request for extended-year employment by \$800,000; now therefore be it

RESOLVED, That the Board of Education establish an Adult Education/Summer School Enterprise Fund; and be it further

RESOLVED, That the Board of Education set summer school fees for FY 92 as shown on the fee schedule; and be it further

RESOLVED, That the Board of Education will request the County Council to approve an emergency supplemental appropriation for the amount that exceeds the projected revenue that was included in the Board's FY 92 Operating Budget request approved in February.

RESOLUTION NO. 476-91 Re: PROFESSIONAL AND CLERICAL PART-TIME, FY 1992 OPERATING BUDGET

On recommendation of the superintendent and on motion of Mrs. Gutierrez seconded by Dr. Cheung, the following resolution was adopted unanimously#:

RESOLVED, That the Board of Education approve the reduction in professional and clerical part-time accounts, FY 1992 Operating Budget, in the amount of \$400,000.

A motion by Mrs. Hobbs to remove the position of coordinator of vocational program development from the list of central office reductions failed with Dr. Cheung, Ms. Gutierrez, and Mrs. Hobbs voting in the affirmative; Mrs. Brenneman, (Mr. Chang), Mrs. DiFonzo, Mr. Ewing, and Mrs. Fanconi voting in the negative#.
