Re: **BOARD/SUPERINTENDENT COMMENTS**

Ms. Malik reported that she went to a presentation of the Islamic Center of Maryland on Ramadan. She noted that this was the second week of school, but the athletes have been practicing for more than a month.

Mr. Barclay stated that he attended the presentation by the Islamic Center of Maryland for Ramadan. He also had the opportunity to do a community walk in Takoma Park, and he was presented with a report— Silver Spring Loves Teachers. It was a good report written by parents about quality teachers. He recognized the press conference at Shady Grove Middle School, which included an opportunity to see the Promethean boards and how they work.

Dr. Docca visited school the first day of school with the superintendent. Richard Montgomery High School has a new camera system, and it very sophisticated. It can zoom in on images and staff can see everything in the halls, with recordings in the school and Central Office. The International Student Admissions Office open house had many families enrolling their children before school. Also, she attended Walk Safe, a pedestrian safety conference, and an event in honor of African Heritage Month, declared by the county executive.

Mr. Abrams noted that Richard Montgomery High School is becoming the new destination for Montgomery County because of its artificial turf. He gave kudos to Ms. Cox on her comments regarding Majority Leader Barve's latest intervention in micromanaging education. The Board needs to get his attention and disabuse some of the misinformation that exists on the issues of fees and policy. The Board needs to make sure there are no impediments for those who cannot afford fees and make their needs known. He has written an op ed piece regarding the slots referendum and its impact on Montgomery County's education funding. In looking at the proposal, the Board stands to be more at risk rather than beneficiaries if the package is passed. He said he was not philosophically opposed to slots in Maryland; however, he feels that this proposal package essentially forces those of us in education who are relying on new funding sources to go into this with

one arm tied behind our backs. The sites that have been designated in the legislation do not actuarially lead to revenue streams that the state is counting on nor is there a provision or consideration for the time lag before state funding from slots could reach LEAs.

Mrs. Navarro commented that Ms. Steinberg, legislative aide, contacted Mr. Barve to clarify the misstatements and misinformation. Also, she has been in contact with Delegate Hixon, who is very supportive and understands MCPS policy. The Board has asked the superintendent to look into the fidelity of implementation on fees. She said it is important to be in a two-way dialogue with the delegation.

Mrs. O'Neill reported that Governor O'Malley and County Executive Leggett toured College Gardens Elementary School and Walter Johnson High School. Walter Johnson is undergoing modernization, and she commended the students for their patience during this protracted process. Finally, she noted the passing of Dr. Donald Riddick, former principal of Walter Johnson.

Ms. Brandman reminded the public of community strategic plan forums on September 18 and October 16.

Mrs. Navarro commented on the budget and the gloomy forecast. the Board has begun discussions with president of the County Council and chairperson of the Education Committee to begin to shape what the next budget will look like.

Dr. Docca commended the principals for their practice ensuring that no child goes without materials if parents cannot afford the fees.

Mr. Bowers thanked the Board president for talking about the upcoming budget and dire circumstances. There is a great deal of interest in MCPS from other school systems regarding what goes on here. MCPS is a member of the American Productivity and Quality Center, which has highlighted MCPS for a number of best practices. Also, there will be more visits from national and international school systems, with 30 visits from 17 countries.

Re: WORK PLAN OF THE OFFICE OF LEGISLATIVE OVERSIGHT

Mr. Bowers invited the following people to the table: Ms. Karen Orlansky; Dr. Elaine Bonner-Tompkins, senior legislative analyst; Mr. Aron Trombka, senior legislative analyst; Ms. Kristen Latham, legislative analyst; and Mr. Rich Romer, legislative analyst.

The Board of Education has expressed an ongoing interest in the Office of Legislative Oversight (OLO) work projects. On August 19, 2008, Board President Nancy Navarro, Board Vice President Shirley Brandman, and Staff Assistant to the Board of Education Ms. Laura Steinberg, met with Ms. Karen Orlansky, director, Office of Legislative Oversight, to

review the FY 2009 work plan (online). In addition, Board members expressed an interest in reviewing the work plan and discussing it with OLO staff. OLO staff presented their findings of the review of MCPS' recycling efforts.

Re: **DISCUSSION**

Mr. Barclay asked why the upper grades do not recycle as well as the elementary schools. Mr. Trombka replied that the smaller schools perform better, and the biggest correlation is with those schools that have recycling champions.

Mr. Barclay noted the move to milk in plastic bottles with an increased cost. What is MCPS doing to offset the cost? Staff replied that the cost has been offset with different funds, such as grants.

Ms. Cox was impressed with the professionalism of the staff at OLO. The recycling issue could relate to curriculum, and MCPS might consider a review. Ms. Cox referred to the ultimate findings, including food recycling; and asked whether OLO makes recommendations to the County Council for supporting other agencies to make improvements?

Dr. Docca asked how the recycling percentages for MCPS compared with those of the county government. OLO staff agreed to provide the information.

Ms. Malik asked if the report was online. She said she knew that students want to become active in recycling. She asked how a recycling champion is created. OLO staff replied that it is usually a home-grown champion, but an identification and training process could be developed..

Mrs. O'Neill asked for information on the recycling curriculum, and she wanted Central Office to have more recycling containers, especially those for soda cans. Staff agreed to report on both issues.

Mrs. Navarro thanked the OLO staff for presenting the report on recycling, and said she was interested in the work plans for the future, with an opportunity to discuss them with OLO staff.

Dr. Elaine Bonner-Tompkins stated that the work plan is directed by the County Council to more fully understand the MCPS operating budget. The three new projects include (1) high school consortia; (2) workforce readiness for students; and (3) workforce age, composition, and succession planning for county employees.

Ms. Cox asked about the scope of the high school consortia project. One of the bullets included the costs of operating a consortia school versus the traditional approach. OLO

replied that they would like to track the progress of the consortia schools reflected against the trends of the school system.

Ms. Cox asked if there was flexibility in the scope of the project, as charged by the County Council. OLO staff replied that the Council has ideas for a project, and staff works with the Council to describe the project to ascertain the availability of data. On the high school consortia project, it is clear that they have to report on the costs and results based on analysis.

Mr. Barclay thought it was important that, given the resources and the ability of OLO, it was important to use the reports since they were done by an independent body.

Mrs. Navarro wanted to ensure that the reports informed the County Council on the implications of recommendations.

Re: **NEW RACE CODE DESIGNATIONS**

Mr. Bowers invited the following people to the table: Dr. Stacy L. Scott, associate superintendent, Office of Shared Accountability; and Mr. Sherwin Collette, chief technology officer, Office of the Chief Technology Officer.

The federal government uses racial and ethnic data for many purposes, such as ensuring equal access to housing, education, and employment. In 1993, the federal government initiated a complete review of the categories used to collect data on race and ethnicity of the nation's population. Many people felt that the categories, which had been in use for more than 20 years, did not adequately reflect the increasing diversity of the nation's population. A federal committee that included representatives from more than 30 government agencies was established to assist with the review and to ensure that data collection was consistent throughout the government. In 1997, the government published the committee's recommendations on how the categories and process should be revised and received feedback from thousands of individuals on the proposed changes.

In 2007, the U.S. Department of Education (USDE) issued its final guidelines, requiring state education departments to implement the new racial and ethnic categories for public school students. USDE mandated the use of the new codes for reporting race and ethnicity beginning with the 2010–2011 school year. The Maryland State Department of Education (MSDE) is requiring local school systems to report data using both the existing race/ethnicity codes and the new race/ethnicity codes for the 2009–2010 school year. This is one year prior to the federal deadline for implementation and will begin with the September 30, 2009, enrollment reports. Montgomery County Public Schools (MCPS) must collect data from students during the 2008–2009 school year in order to meet that timeline.

Once the forms are returned to CESC, Data Center staff will scan the forms, with the data from the forms being transferred to the Online Achievement Student Information System. Blank forms and monitoring reports will be sent to schools with the first, second, and third marking period report cards to aid schools in their collection of any missing student forms. A final monitoring report for students whose data are missing will be provided to schools in June 2009. Principals have been asked to utilize any and every opportunity available to encourage the prompt return of the form.

Re: STATEMENT BY MRS. NAVARRO

Ms. Navarro commented that the Board met with general counsel today concerning legal

issues that have been raised in recent weeks concerning the establishment and implementation of various school fees. Counsel was asked for advice as part of a continuing effort to examine fees. The Policy Committee will meet tomorrow to review the monitoring process associated with current policy and implementation procedures. In addition, the Board was informed that the superintendent has asked a staff committee to review existing practices regarding fees. The Board will continue to keep the community informed regarding this issue.

Re: ORAL UPDATE ON THE OPENING OF SCHOOLS

Mr. Bowers, Dr. Frieda Lacy, deputy superintendent, and Mr. Steve Bedford, chief performance officer, commented on the beginning of school. There was a short video on the opening of school which feaured many excited students and teachers beginning instruction.

Three principals, Mrs. Yong-Mu Kim, Mrs. Jennifer Baker, and Dr. Christine Handy-Collins, pointed out the successes and new beginnings at their schools.

Mrs. Navarro pointed out that the Board makes decisions about the strategic plan and the budget. These decisions can sometimes seem detached from the daily work at the school building. For her, the updates highlighted progress in internalizing the vision of the strategic plan at the building level and the uniformity with flexibility to build a culture in the school. She commended staff for consistency and patience the reform efforts.
