WHEREAS, The Board of Education approves tuition fees each year for summer school; and

WHEREAS, Summer School Revenue-based Program costs are projected to rise only slightly; now therefore be it

Resolved, That the Summer School Revenue-based Program full fees be maintained at the current FY 2011 rate (\$335 for elementary school courses; \$300 for high school courses; and \$310 for student online courses); and be it further

Resolved, That the Summer School Revenue-based Program reduced fees be maintained at the current FY 2011 rate (\$85 and \$120, respectively, depending upon family income); and be it further

Resolved, That the total annual family income guidelines for qualifying for reduced fees and waivers be maintained at \$0–\$29,812 for the lowest reduced fee; \$29,813–\$42,425 for the higher reduced fee; and below \$42,425 for waivers; and be it further

Resolved, That the Summer School Minimal Fee-based Program course fees be maintained.

Re: **DISCUSSION** 

Mrs. O'Neill stated that the Board has asked a lot of questions prior to this day and adoption of the budget; therefore, there will not be a great deal of debate and amendments. Furthermore, the Board does not know what the funding recommended by the Council and executive will be. Everyone is very concerned about reductions in June. At this point, the wise thing to do is adopt the Maintenance of Effort budget.

Mr. Berthiaume stated that she would support the substitute resolution. This is the beginning of a process, and everyone will be on a roller coaster until June. The non-recommended reductions are suggestions, and there could be deeper reductions based on local/state funding.

Ms. Brandman noted there were still a lot of it matters to be resolved, such as federal and state funding, local funding, and negotiations with unions. Leading up to June, the Board will have more information. At this point, the Board must follow its legal obligation and comply with the state's maintenance of effort law. Reductions are all painful choices, but the Board must make choices to meet goals and competing priorities. In approving this budget, the Board is taking the first step.

Dr. Docca stated that she will vote for the budget since the Board is legally and morally bound to comply with state law. It is essential to fund the budget to meet the needs of students that are coming to MCPS, such as those in poverty. It is the responsibility of the Board to educate the children in Montgomery County.

Mr. Kauffman stated that he was supporting the budget. He associated his remarks with those of his colleagues. The proposed budget is legally required and the right thing to do for the students. The formula dictates more funding since enrollment is growing, which requires more teachers, bus drivers, space, and textbooks, among other things. The Board should not apologize or be defensive. The Board recognizes the fiscal reality, and it will work with the Council.

Mr. Durso agreed with his colleagues. The process is going to be challenging since there are many variables.

Mr. Barclay commented that the final vote will be in June. Montgomery County is not the wealthy enclave it once was, and it is in a dire situation. Enrollment is exploding, with more needs; NCLB has increasing standards; over the last two years \$250 million has been eliminated; non-recommended reduction equal \$50 million. Every student in the county will be affected by any reduction. The issues facing the Board are negotiations; general assembly actions; Council not funding Maintenance of Effort; etc. The Board must adopt a Maintenance of Effort budget because it is the law and the right thing to do. The budget is a moral document and a commitment to our children. The budget is not a "what I want" but

"what I need." The suggestion that the Board ignores the law and asks for less sends the message to kids is that we do not care.
