OPERATING BUDGET INTERESTS

Dr. Starr engaged the Board of Education in an exercise to discuss any broad budget interests that the Board may have. This is a useful process to be fully aware of the interests of the Board. It also enhanced transparency and led to a richer discussion of the operating budget over the course of the year. In preparation for this session, it is important that everyone has a common understanding of interest-based problem solving and the importance of focusing on interests and not positions.

The school system is in the early process of developing the operating budget. This exercise will likely yield only preliminary insights from the Board. Administration will be seeking feedback and involvement from our many stakeholders throughout the budget process until its culmination in May 2012.

WHEREAS, On May 4, 2011, the Board of Public Works approved the allocation of \$8.6 million in funding for the Aging Schools Program to those jurisdictions that will participate in the Fiscal Year 2011 Aging Schools Program; and

SUPERINTENDENT'S RECOMMENDATION FOR THE MODERNIZATION OF WHEATON HIGH SCHOOL AND THE THOMAS EDISON HIGH SCHOOL OF TECHNOLOGY

On recommendation of the superintendent and on motion of Mrs. O'Neill seconded by Mr. Kauffman, the following resolution was adopted unanimously:#

WHEREAS, On March 28, 2011, the Board of Education directed staff to conduct a feasibility study for Wheaton High School and the Thomas Edison High School of Technology and facilities that included two concepts: (1) two buildings on one site (Option A); and (2) one building with separate entrances, separate identities, and separate driveways (Option B); and

WHEREAS, The Wheaton High School/Thomas Edison High School of Technology

Facility Advisory Committee met from April 2011 through June 2011 and completed the feasibility study; and

WHEREAS, The Wheaton High School/Thomas Edison High School of Technology Facility Advisory Committee selected Option A, the two-building option, as the preferred option; and

WHEREAS, The recommended Option A will be less disruptive to school operations during the construction phase and will cost less than Option B; and

WHEREAS, The draft report of the feasibility study was available for public comment from July 18, 2011, through August 19, 2011; and

WHEREAS, The superintendent of schools reviewed and carefully considered the input from the Wheaton High School/Thomas Edison High School of Technology Facility Advisory Committee and the community at-large and concurs with the recommendation; now therefore be it

Resolved, That Option A, the two-building option, is selected for the modernization of Wheaton High School and the Thomas Edison High School of Technology; and be it further

Resolved, That the completion date of the entire project be August 2018, pending approval of funding by the Montgomery County Council for construction funds in the Fiscal Year 2013–2018 Capital Improvements Program.

WHEREAS, The Facility Advisory Committee for the William H. Farquhar Middle School modernization met from March through June 2011 and completed a feasibility study; and

WHEREAS, The draft of the feasibility study for the modernization of William H.

Farquhar Middle School was available for public comment from July 18, 2011 through August 19, 2011; and

WHEREAS, The Facility Advisory Committee recommended the land swap option with a two-story school building, identified as Option One in the feasibility study, as the preferred option; and

WHEREAS, Staff in the Department of Facilities Management recommends the land swap option with a three-story school building, identified as Option Two in the feasibility study, as the three-story building offers a smaller building footprint that allows more land for site amenities and green space; and

WHEREAS, The recommended Option Two requires review and approval by the Maryland-National Capital Park and Planning Commission; and

WHEREAS, Staff in the Department of Facilities Management recommends the relocation of students to the Tilden Holding Center and construction of the replacement facility at the location of the current building, identified as Option Four in the feasibility study, as the back-up plan in the event that the Maryland-National Capital Park and Planning Commission does not support the land swap option; and

WHEREAS, The superintendent of schools concurs with the recommendations by staff in the Department of Facilities Management; now therefore be it

Resolved, That the Board of Education strongly supports the land swap option with a three-story school building, identified as Option Two in the feasibility study, is selected for the modernization of William H. Farquhar Middle School; and be it further

<u>Resolved</u>, That the relocation of students to the Tilden Holding Center and construction of the replacement facility at the location of the current building, identified as Option Four in the feasibility study, is the back-up plan if the Maryland-National Capital Park and Planning Commission does not support the land swap option; and be it further

Resolved, That staff in the Department of Facilities Management begins the process with the Maryland-National Park and Planning Commission to facilitate the land swap option; and be it further

Resolved, That design development for the replacement school on the undeveloped land adjacent to William H. Farquhar Middle School begin in fall 2011, and construction for the replacement facility begin in summer 2013, pending approval by the Montgomery County Council for construction funds as part of the Fiscal Year 2013–2018 Capital Improvements Program.

Re: ORAL UPDATE ON THE SUPERINTENDENT'S TRANSITION REPORT

Dr. Starr stated that he was pleased to share with the Board the work of the transition team, which will provide him with an assessment of what Montgomery County Public Schools (MCPS) is doing well and what areas need additional focus. The team reviewed a great deal of data and delved into the operations of our school system in order to give him a deeper understanding of the work done to date. The team reviewed documents, conducted numerous interviews, and held focus groups to hear from stakeholders and to understand the dynamics of MCPS. This will be the first of several dialogues with the Board about the report and what Dr. Starr has been learning in his initial months as superintendent of schools.

This report, as well as my "Listen and Learn" events, will provide Dr. Starr with a strong foundation of knowledge to lead our work going forward. It is clear to him that while much good work has gone on in MCPS, MCPS is a district poised for even greater success.

RESOLUTION NO. 450-11 Re: **FINAL ACTION, POLICY IOD, EDUCATION OF ENGLISH LANGUAGE LEARNERS** 

On recommendation and motion of the Policy Committee, the following resolution was adopted unanimously:

WHEREAS, Policy IOD, Education of English Language Learners, reaffirms the education of English language learners as a high priority for Montgomery County Public Schools and also ensures compliance with federal and state mandates regarding the education of English language learners; and

WHEREAS, The draft of Policy IOD, Education of English Language Learners, was tentatively adopted by the Montgomery County Board of Education on March 8, 2011, and was sent out for public comment; and

WHEREAS, The Montgomery County Board of Education has received comments and the Board of Education Policy Committee's recommendations; now therefore be it

<u>Resolved</u>, That the Montgomery County Board of Education adopt Policy IOD, Education of English Language Learners, as updated in the attached committee recommended draft.

#### A. PURPOSE

To reaffirm the education of English language learners as a high priority for Montgomery County Public Schools (MCPS)

To ensure compliance with federal and state mandates regarding the education of English language learners

#### B. ISSUE

Success for every student is based on the premise that quality education is a fundamental right of every child. Language should not be a barrier that impedes English language learners in their effort to secure equal educational opportunities in MCPS. English language learners have become an increasingly diverse group of students, representing many countries and languages, coming from all socioeconomic levels, and having varied educational and experiential backgrounds. There must be special instructional and support programs to meet the challenges faced by English language learners, including services such as counseling, parent outreach, and bilingual assessments that will help eliminate barriers that might prevent students from participating fully in educational programs. Instruction should enable students to learn English as quickly as possible while at the same time ensuring that they do not fall behind their gradelevel peers in content areas.

#### C. POSITION

- 1. It is the intent of the Montgomery County Board of Education to:
  - a) Hold English language learners to the same high expectations of learning established for all students;
  - b) Assure that English language learners develop full proficiencies in academic and interpersonal English in the domains of listening, speaking, reading, and writing, consistent with expectations for all students;
  - c) Assure that English language learners reach challenging content and performance standards in all content areas, including reading and language arts, mathematics, social studies, science, career and technology education, the fine arts, health, and physical education, consistent with those for all students;
  - d) Provide appropriate instruction to English language learners regardless of their previous education, cognitive abilities, or special needs and that reflects their English language proficiency levels;
  - e) Evaluate English language learners with appropriate and valid assessments that are aligned with federal, state, and local standards and that take into account the English language proficiency levels and cultural backgrounds of the students; and
  - f) Recognize that the academic success of English language learners is a responsibility shared by the students, all educators, the family, and the community.
- 2. The English for Speakers of Other Languages (ESOL) Program
  - a) Each school, in collaboration with the Office of Curriculum and Instructional Programs and the Office of School Performance, will provide an ESOL program to respond to the range of needs of eligible English language learners. ESOL is a specialized English language development instructional program for eligible English language learners who need to develop proficiency in the four language skills of listening, speaking, reading, and writing academic and interpersonal standard American English.
  - b) The ESOL curriculum:
    - (1) Is research based;

- (2) Is based on age-appropriate levels of English language proficiency;
- (3) Is aligned with the English language proficiency standards in the Maryland State Department of Education English language proficiency state curriculum;
- (4) Is aligned with the reading and writing purposes of the MCPS English/Reading/Language Arts curriculum;
- (5) Is reflective of the many cultural and linguistic backgrounds represented by English language learners; and
- (6) Is taught using the content, strategies, and thinking processes that students encounter as they pursue an education in MCPS.

#### c) Related ESOL Services

- (1) Schools will employ appropriate, relevant, and culturally sensitive approaches to ensure that parents of English language learners are informed about and become involved in their children's education.
- (2) MCPS will provide ESOL counseling to assist ESOL program participants in their new school and community environment.
- (3) MCPS will provide assessments that minimize cultural and linguistic biases for English language learners who are suspected of having a disability.
- d) Staff development in the instructional needs of English language learners is an integral component of a quality ESOL program. Staff development opportunities will be made available to all staff.

#### 3. Identification and Completion

- a) An English language proficiency assessment will be administered by qualified and trained assessors to all students whose home language is not standard American English at the time they initially enroll in MCPS to identify English language learners eligible for the ESOL program and determine their level of English proficiency.
- b) Students participating in the ESOL program will be considered

English proficient and designated as Reclassified English language learners upon meeting the criteria established by Maryland State Guidelines.

- c) Performance of students who have exited from the ESOL program will be monitored by the English language learner team in each school and appropriate accommodations will be provided for a period of two years.
- d) Identification and program completion procedures will be evaluated periodically and revised as necessary.

#### D. DESIRED OUTCOMES

- Services of the ESOL program will be offered to all eligible English language learners and will be designed to accommodate diversity in student backgrounds and levels of English language proficiency.
- 2. The expectation for success for students participating in the ESOL program will be consistent with expectations for all students in MCPS.

#### E. IMPLEMENTATION STRATEGIES

The superintendent of schools will:

- Issue administrative procedures for the development, maintenance, and evaluation of appropriate programs for English language learners in MCPS;
- 2. Allocate staff and material resources annually, based on documented needs and within existing budgetary constraints;
- 3. Apply for appropriate federal financial assistance, where available, to implement this policy; and
- 4. Work collaboratively with other county agencies and community organizations to access resources and help meet the needs of English language learners and their families.

#### F. REVIEW AND REPORTING

- 1. Each year, the academic progress of ESOL program participants will be reported to the Montgomery County Board of Education through the annual report.
- 2. MCPS will fulfill all federal and state reporting requirements for current and past ESOL program participants.

3. This policy will be reviewed in accordance with the Board of Education policy review process.

Council of Supporting Services Employees the exclusive right to represent its supporting services employees in the mutual development of guidelines regarding salary and other working conditions for input into the budget; and

WHEREAS, In 1978, the *Annotated Code of Maryland, Education Article,* Section 6, Subtitle 5, was amended to establish organizations of noncertificated public school employees; and

WHEREAS, The Service Employees International Union (SEIU) Local 500, in accordance with the requirements of the *Annotated Code of Maryland, Education Article*, Section 6-506, requested the opportunity to enter into negotiations with the Board of Education on the subject of establishing a bargaining unit for noncertificated nonsupervisory employees; and

WHEREAS, The SEIU Local 500, Montgomery County Council of Supporting Services Employees (SEIU Local 500, MCCSSE) was properly designated as the employee organization to be the exclusive representative for these negotiations; and

WHEREAS, The employee organization recognized as the Montgomery County Council of Supporting Services Employees (MCCSSE) is now identified as the Service Employees International Union (SEIU) Local 500, and has continued to serve as the exclusive representative and negotiating agent for the public school employees in its bargaining unit; now therefore be it

Resolved, That in accordance with the provisions of the Annotated Code of Maryland, Education Article, Section 6-506 (e) Designation without an election, the Board of Education reaffirms SEIU Local 500 as the exclusive representative of noncertificated nonsupervisory employees.

Re: POLICY HDD, DESIGNATION OF THE MCAASP AS EXCLUSIVE REPRESENTATIVE OF NONCERTIFICATED SUPERVISORY EMPLOYEES
