## Meeting Notes:

- 1.0 The purpose of this meeting was to review the project schedule and discuss what will be happening on site.
- 2.0 Hess Construction reviewed the project schedule:
  - 2.1 Demolition of the existing building: (The area around building will be fenced)
  - 2.2 Utility Disconnections
  - 2.3 Construction of New Building

Mid-February through April 2021

Ongoing Late April 2021- July of 2023. M

- Entire site will be fenced.
- MCPS and Hess Construction trailers will be located on site.
- All construction access to the site will be from Old Georgetown Road.
- Construction traffic will use existing curb cuts.
- All construction workers will park on site.
- Sediment traps will be installed.
- 3.0 The fields on the eastern half of the site will not be available for public use after February 2021.
- 4.0 Some work will take place in Old Georgetown Road and in the Right-of-Way.
  - 4.1 Lane closures will take place.
  - 4.2 Hess Construction will notify the community.
- 5.0 Portions of the sidewalk along Old Georgetown Road will be closed.
  - 5.1 Hess Construction will coordinate with MCPS on sidewalk closures.
- 6.0 Retaining wall owned by adjacent property owners along the south property line is failing and will be repaired in the near future.
  - 6.1 Construction crews hired by the HOA may need access to MCPS property in order to perform the repair/replacement work.
  - 6.2 Adjacent Property Owners to coordinate with MCPS's on-site inspection team, and Shiho Shibasaki from the Division of Design and Construction.
- 7.0 A community member asked if any construction traffic will be using Edson Lane.

**Response:** It depends on where the construction vehicles coming from. However, there is no plan to use the property north of the school property to access the site at this point.

- 8.0 A community member asked what will happen to the trees located in the southeast corner of the site. *Response:* The LOD (the limit of disturbance) has been placed to minimize the impact on the trees.
- 9.0 A community member asked if weekly community updates could be provided via email. *Response:* Hess Construction can provide weekly updates once the construction starts.
- 10.0 A community member asked about the recent community presentation made by SBA regarding the Cellular monopole.
   *Response:* Existing monopole will be relocated and replaced by a new monopole at another location on site.
   New monopole will be taller than existing pole, since it is located at a lower elevation, and the new building is taller than the existing building.
- 11.0A community member asked if the pathway between the Mains Community to the east will be maintained. *Response:* The pathway at the mains will not be maintained.
- 12.0A community member asked if the pathway between Timberlawn Park and the site will be maintained. *Response:* A new pathway will be provided as part of Phase 2.
- 13.0A community member asked if an agenda for the following meeting can be provided prior to the meeting, and if graphic information and timelines can be provided.
  - **Response:** An agenda for the next meeting can be distributed prior to the meeting. Graphic information from presentations can be provided on the MCPS Website.
