#### CONTEST GUIDELINES

- All MCPS elementary, middle, and high school students and staff are eligible to enter the contest.
- Posters must encourage others to conserve energy and to recycle responsibly.
- Art must be the original work of a student or staff member and must not contain any copyrighted elements. Artwork should be work the artist has created alone.
- For the best results, artwork should be no smaller than 8.5"x 11" and no larger than 18"x 24" in size.
- All entries must be accompanied by the official 2020 contest entry form, • which can be found on our website. Student entry forms must be signed by the student's parent or guardian AND the school principal.
- Three entries per grade level per school will be accepted. Schools are asked to hold preliminary competitions and submit the best three entries by staff and from each grade.
- Physical entries may be sent to SERT via Pony or first class mail, or handdelivered and must be received by the SERT program on or before Monday, April 1, 2020. The SERT program will not be responsible for lost or damaged artwork.
- Digital entries should be emailed to SERT@mcpsmd.org by or before the April 1 deadline.
- Upon submission, entries become property of MCPS and will not be returned. Artwork and artist information may be used in future public awareness campaigns by MCPS.

#### POSTER JUDGING

The initial round of poster judging is done by SERT staff. For the past three years, we've used the Google platform and invited MCPS students and staff to participate in the final round of judging. The same process will take place this year. Watch this newsletter, our website, and the MCPS staff bulletin for more details. Contest winners will be announced before the school year ends.

## Let's Work On Our Recycling Resolutions

AS WE BEGIN ANOTHER YEAR, we hope that you remembered to include "recycle responsibly" to your list of New Year's resolutions! MCPS recycles in accordance with Montgomery County's <u>recycling regulation</u> so it's important to know which items can and cannot be recycled in our county. As you review this list, you may find a few more items that you can include in your recycling bins. Simple general rules to remember are that all of your plain, "flat" paper and cardboard boxes can go into the mixed paper recycling bin while all the aluminum foil, foil serving trays, bottles, cans, and plastic containers should be placed in the commingled recycling bin. Also remember that we do NOT recycle #6 plastics in Montgomery County.

#### MIXED PAPER

#### ACCEPTABLE PAPER ITEMS

- Empty milk and juice containers
- ✓ Lunch trays, paper boat trays, paper plates and cups
- ✓ Newspapers (with inserts)
- ✓ Magazines, catalogs, junk mail, and windowed envelopes
- Cardboard and paperboard boxes (including all cereal boxes without the liners, frozen food packaging, etc.)
- ✓ Corrugated cardboard (all boxes must be broken down)
- ✓ Spiral notebooks and composition books
- ✓ Colored paper, theme paper, and used copier paper
- ✓ Books (including paperbacks, textbooks, and hardbacks)
- Shredded paper contained in a sealed or tied clear plastic bag
- ✓ Non-metallic wrapping paper
- Paper bulletin board decorations
- ✓ Brown paper bags
- ✓ Telephone books
- ✓ Construction paper
- ✓ Files and folders
- ✓ Cardstock



#### UNACCEPTABLE PAPER ITEMS

- × Paper towels, tissues
- Any paper contaminated with food waste, including paper plates and cups
- Metallic wrapping paper
- Laminated paper
- Loose, shredded paper, and plastic-coated paper

#### **COMMINGLED ITEMS**

#### ACCEPTABLE PLASTIC, BOTTLES, CANS

- ✓ Black plastic (PET Plastic #1) food containers
- ✓ Empty plastic milk, juice, and water bottles
- ✓ PET #1 Thermoform plastic packaging, such as clamshell containers, trays, deli containers, lids, and caps
- ✓ #1, #2, #3, #4, #5, #7 rigid plastic containers, including bottles, jugs, wide-mouth tubs, caps, salad and vegetable containers
- ✓ Aluminum food and beverage containers
- ✓ Bi-metal steel/tin cans, such as soup and vegetable cans
- ✓ Clean aluminum foil and aluminum pie pans
- ✓ Glass containers: brown, clear, and green glass containers jars and bottles
- ✓ Empty non-hazardous aerosol cans
- Plastic buckets with metal handles (such as floor wax and stripper)
- ✓ Plastic flower pots
- ✓ Plastic drinking cups/glasses (stadium cups)
- ✓ Plastic 5-gallon water bottles

#### UNACCEPTABLE PLASTIC, BOTTLES, CANS

- ★ #6 plastic containers
- Styrofoam (cups, plates, bowls, to-go containers, and foam packing material of any kind)
- \* Materials contaminated with food waste or grease
- Trash/food waste
- Colored plastic film (such as candy and food wrappers or bags, colored plastic shopping bags)
- Plastic cutlery (forks, knives, spoons)
- Non-container glass (cookware, plate glass, window glass)
- Motor oil, anti-freeze, and pesticide containers
- Ceramics
- Construction and demolition material
- × Vinyl siding
