OSHA-Recordable Injury/Illness Incidence Rate

What makes an injury or illness OSHA-recordable\*?

- Work-related
- Results in:
  - Lost work days,
  - Job transfer or restriction,
  - Medical treatment beyond first aid, and/or
  - Death

<sup>\*</sup>Must be recorded on annual OSHA 300 injury/illness log form.

# How do we measure injury/illness rates?

# OSHA-Recordable Injury/Illness Incidence Rate

#### What is an incidence rate?

- Number of OSHA-recordable injuries/illnesses (ORs) per 100 full-time employees
- Permits comparison of relative injury/illness rates between employers of different sizes, industries
- Can assist in identifying problem areas, operations within organizations
- Can be compared to state, national data (where available)

### How do we calculate incidence rate?

No. of ORs \* 200,000<sup>1</sup> / Total hours worked by employees

<sup>&</sup>lt;sup>1</sup> This represents the total hours worked in a calendar year by 100 full-time employees: 2,000 hours for 100 employees (2,000 \* 100 = 200,000).

## What is MCPS' incidence rate?

Systemwide Incidence Rate (CY23)

No. of OSHA-Recordable Injuries and Illnesses \* 200,000 / Total hours worked by employees =

1,179 ORs \* 200,000 / 36,746,443.26 = 6.4

6.4 OSHA-Recordable Injuries/Illnesses per 100 full-time employees
