
Take care. Stay safe. Get vaccinated and hope to see you in October.

TOOLKITS PROJECT POSTPONED



When we were forced to place our Toolkits Project on hold last year at this time, we were experiencing great anxiety and uncertainty over just how much our lives would be altered and for how long we would be dealing with the COVID-19 pandemic. It was inconceivable to think that 12 months later the virus would remain a deadly threat and we would still be in the process of redefining and



establishing a new normal. Although we are a resilient society determined to defeat the virus and move forward, moving forward has sure been slow.

That being said, we were hopeful all year long that we would be able to resume the assembly and distribution of toolkits for needy kindergartners who would be participating this summer in the Extended Learning Opportunities Summer Adventures In Learning (ELO SAIL) Program at selected Title I schools. We communicated with Title I coordinators throughout the spring to try to get crucial information regarding dates, projected numbers of participants, how the program would be conducted both in-person and by virtual learning, how many kits would be requested, which students would be eligible to receive one, and how the kits would be distributed. The logistics of how we could determine all this in time to actually go into production became more and more impossible as the weeks went by. Kindergarten Roundup in the elementary schools is usually conducted in early spring but this year it has been done virtually or by appointment and is still being conducted. Registration for the ELO SAIL Program didn't start until May 3.

We remained optimistic that we could continue planning to assemble the kits then other obstacles surfaced:

- First, Target, where we have acquired the plastic shoe boxes at cost for nearly 10 years, informed us that they are not taking bulk orders for anything until further notice. After an exhaustive search the only company that might be able to supply them offered them to us for \$7,500, more than 3.5 times more expensive than in years past, and they could not guarantee a delivery date.
- Second, several of the items included in the toolkits (i.e., magnetic letters, scissors, Play Doh, glue sticks) are produced overseas, mainly in China, and are not being shipped at this time.



Therefore, our MCPSRA Special Projects Committee members along with the Title I Coordinator came to the heart-breaking conclusion that our Toolkits Project must be postponed until next year.

Members of the committee are bagging bottle caps that were donated prior to the pandemic. They will be ready when we resume assembling the kits for next summer. We are not accepting any new donations of caps until it is safe to do so again. We must continue our fundraising efforts since the expenses for 2,200 kits each summer average nearly \$30,000. Thus far this year we've received 142 donations totaling \$12,035. MCPSRA Consumer Report by Reggie Ott

Your membership in MCPSRA assures that you are a member of the Maryland Retired School Personnel Association (MRSPA). As a result, you have access to the bi-monthly Consumer Connection Newsletter published by the MRSPA Consumer Education Committee which offers a full array of consumer information.

1. Federal Taxes must have been filed by May 17, 2021; Maryland State Taxes are due July 17th, 2021. (Note the new 1040-SR form below.)

- Be aware that you should not engage in services claiming to be able to expedite getting you additional money or faster delivery by filing your return for a fee. There are

unscrupulous companies which are promising you can settle tax liens for pennies on the dollar through a compromise.

- Big takeaway: The IRS will never call you demanding payment. The IRS doesn't use social media, text, or emails. The IRS will not ask for gift cards as payments.

2. The easiest way to protect yourself from solicitations and scams is to pay attention to your caller ID. If you don't recognize the number, even if it is local or seems legit, let the call go to voice mail. If it's a friend, you will get a message and you can call right back. If you inadvertently answer a call that turns out to be unwanted, just say "Thank you for calling" and hang up immediately. Do not engage in conversation. These people want your money, and they are good at getting it!

3. How to help others during the Pandemic:

- Check on seniors, disabled or other at-risk neighbors in your area. Since there are issues around contact, leave a note or card on their doorstep so they can know that they can reach you.
- Schedule regular chats by phone with homebound individuals.
- Don't have a neighbor in need? Check with your local place of worship to see if there are any ways that you can help their aging attendees.

Notes from MRSPA Consumer Connection, March-April, 2021

4 This year's COLA rate for the fiscal year beginning July 1 is 1.234%. The increased monthly benefit will be shown on the Automatic Deposit Advice mailed to the homes of all retirees on July 31.

A retiree who has been retired at least one year as of July 1, 2020 qualifies for this year's COLA. Those who retired after July 2020 (August 2020 or later) will be eligible to receive their first COLA is July 2022.

During this past year, we modified and added to our Vision and Mission Statement and Bylaws as follows:

- The MCPSRA "Mission and Vision Statement" was amended to include a diversity statement as follows:

Promote and welcome participation of a diverse group of retirees as an essential component of a healthy and thriving organization.

- The following Emergency Powers Referendum was approved by the membership through a mail-in referendum/approval process:

Article IX – Board of Directors, Section 3 (f). Emergency Powers: During a national, state or local emergency, as declared by the appropriate federal, state, or local authorities, that prohibits or otherwise prevents in-person meetings, all functions of the "Membership" as specified in these Bylaws shall be assumed by the Board of Directors.

- Wording in Article X Section 3 was changed from "political" to "elected" as follows:

The Political Action Committee shall be concerned with the policies and procedures of local, state and federal; governments. This will require development of appropriate political actions to support candidates for political elective office.

I would like to recognize MCPSRA members who are retiring from the Board of Directors: Lou D'Ovidio has served as the chair of the Political Action Committee sending

candidates for political office questionnaires and biographical forms and invitations to interview


with members of the committee. He has also has been our liaison with the Josiah Henson Museum and Park.

- **Public Relations:** helps keep members connected by sharing their stories.




