## Grade 2 & 3 Families...

#### Grade 2 SIPPI Screening

All Montgomery County Public Schools (MCPS) Grade 2 students participate in universal screening as part of the Student Instructional Program Planning and Implementation (SIPPI) process. This process involves gathering information about students to plan instruction for the upcoming school year and for gifted and talented designation. The process gathers information from a variety of sources, including parents, school staff, student performance on district assessments, and a cognitive abilities assessment.

School staff will consider the following information in the SIPPI process:

- Parent Input Form
- Staff Advocacy Survey
- Homeroom Teacher Survey
- Reading Oral Records
- Measures of Academic Progress (MAP) Mathematics
- Cognitive Abilities Test™ (CogAT®)

Grade 2 students will complete Cognitive Abilities Test<sup>™</sup> (CogAT®) in March. The three subtests of the assessment measure: verbal reasoning, quantitative reasoning, and nonverbal reasoning.

You have the opportunity to observe your child in a different setting and may notice special skills or qualities that may or may not be evident in the classroom. School staff wants to consider information you can provide to plan your child's instructional program. You will receive the Parent Input Form in the mail during the week of February 24, 2020. Please complete and return the form to school within two weeks of receiving it. Our school staff will use this information to plan your child's instructional program for the 2020–2021 school year, and to determine gifted and talented designation.

Screening at Bethesda Elementary will be held on March 20, 2020.

In June, you will receive a letter from our school indicating your child's instructional recommendations for the 2020–2021 school year and whether they met the MCPS criteria for gifted and talented designation. If you have any questions, please contact Karen Sanchez. Karen\_G\_Sanchez@mcpsmd.org

#### Upcoming Testing Opportunities for Students in Grade 3

Each student new to Montgomery County Public Schools (MCPS) in Grade 3 has the opportunity to be screened for gifted and talented (GT) identification, and to determine his/her ability or potential to participate in accelerated and enriched instructional programming at their local school. If your child was recommended to participate in the rescreening process for gifted and talented (GT) identification in grade two, as part of the SIPPI Screening, they can be rescreened in February. Letters were sent in backpacks on January 31, 2020.

During this process we gather information about your child from a variety of sources, including a parent survey, homeroom teacher survey, school staff survey, performance on district mathematics and reading assessments, and a \*cognitive assessment that will be administered at school on February 25, 2020. If your child is absent on the date of the assessment, a make-up date will be provided by the school that is within the testing window of February 26-28, 2020.

Information will be sent from MCPS regarding the testing for the Centers for Enriched Studies screening. The testing is scheduled for February 25, 2020.

## BE Updates...

#### Safe Routes to School Program...

We have been working together with the Maryland Department of Transportation and the Safe Routes to School Program to improve pedestrian safety around the school. Below are changes that have been put in place thus far...

• The county recently adjusted signal timing along Arlington Road at Moorland in Fall 2019. MDOT is currently coordinating with the County regarding any additional signal timing adjustments that can be moved forward at MD 187 at Arlington Road.

• The speed limit reduction limits extended from MD 187 (Old Georgetown Road) to MD 191 (Bradley Boulevard). The speed limit along MD 188 was reduced from 30 MPH to 25 MPH in spring 2019.

• MDOT established a School Zone along MD 188 (Wilson Lane) from Clarendon Road to MD 187 (Old Georgetown Road)/Arlington Road, a distance of approximately 650 feet. Appropriate school signage was also installed.

• Half of the Continental Crosswalks at MD 187 at MD 188 and Arlington Road intersection were installed and the remaining ones will be done later this month weather permitting.
