Synergy

Parents/guardians should sign up for a Synergy account to gain access to the gradebook to monitor their child's grades. If you have a Synergy account from last year, the account will carry over. Families new to MCPS should have received Synergy sign-up information via USPS. Contact the main office if you need assistance signing up for your Synergy account. Interim reports will be available in Synergy on October 14, 2021; December 15, 2022; March 6, 2022; and May 18, 2022. Report cards will be available in Synergy on November 11, 2021; January 31, 2022; April 8, 2022; and June 23, 2022.

Grades

See below for the grading scale and grade explanations for elementary students. Academic grades, learning skills grades, and instructional reading and math levels will be reported on the report card.

Graded Opportunities

Reteaching & Reassessment Opportunities

- Students will be provided with reteaching opportunities if they do not demonstrate understanding of a topic or concept over the course of the marking period or unit.
- Students will be provided reassessment opportunities after reteaching.
- When tasks/assessments are reassessed, they may be reassessed partially, entirely, or in a different format, as determined by the teacher.
- The reassessment grade replaces the original grade (if higher than the grade previously earned).
