Sort Your List

Once you have a list of colleges you think you will be satisfied attending, sort it into three categories:

Safety: These are colleges that you feel you have a very good chance of getting into and that you think you can afford to attend. They should also be colleges you would be happy to attend.

Target: These are colleges that you feel you have a good chance of getting into and that are good matches for you overall.

Reaches: These are colleges that you think may be more of a challenge to get into. Getting in is not a sure thing, but it's realistic enough to be worth the effort of applying.

Deadline.....method of application....document transmission method

NON-Restrictive Application Plans:

- Early Action/Priority- Apply early and receive a decision well in advance of the institution's regular response date
- Regular Decision- Students submit an application by a specified date and receive a decision in a clearly stated period of time
- Rolling Admission- Institutions review applications as they are submitted and render admission decisions throughout the admissions cycle

Restrictive Application Plans

- Early Decision **BINDING**- Students make a commitment to a first choice institution where, if admitted they definitely will enroll. The application deadline and decision deadline occur early.
- Restrictive Early Action - Students apply to an institution of preference and receive a decision early. They may be restricted from applying ED or EA or REA to other institutions. If offered enrollment, they have until May to confirm.

Common Application

- Accepted by over 900 colleges
- www.commonapp.org - click on "apply now"
- Use a PERSONAL email for college applications, not your MCPS email
- Common app opens August 1 every year but an account can be created at any time
- Guided tutorial for users after an account is created
- Time it takes varies based on school's requirements- allow six weeks to get everything together for applications
- Be sure to match your account with Naviance-directions for matching in your Naviance account
- Essay word count maximum 650

The Coalition Application

- Accepted by over 150 colleges and universities
- www.coalitionforcollegeaccess.org
- Locker offers a digital space where you can organize everything-can begin as early as 9th grade
- Essay word count maximum 550
- Every Coalition app school is committed to providing strong financial aid and an affordable college experience to students.

The College Essay

- Write about something that is not found on your application
- Include a “hook” – usually added at the end
- It does not have to have a happy ending but has to be honest
- Read your essay aloud
- Colleges want to learn about growth
- Tell a good story
- Write like you speak
- Imagine how the person reading your story will feel-will you be a good fit on their campus?
- Be sure to have someone review your essay and provide feedback

FAFSA- Opens October 1st

- Make a list of schools-you will need to list the schools you are applying to on your FAFSA
- Gather financial documents
 - Social security number
 - Alien Registration number (for Non-US citizens)
 - Federal income tax returns, W-2's, and other records of money earned (may be able to use the tax retrieval online tool)
 - Bank statements and records of any investments
 - Records of any untaxed income
- Create a Federal Student Aid ID at studentaid.gov/h/apply-for-aid/fafsa
Both students and parents need to create a Federal Student Aid (FSA) ID, which will require making a user name and password.
- Start the FAFSA for the desired year- students attending college from July 1, 2021 to June 30, 2020 can file the 2021-2022 FAFSA between October 1, 2020-June 30, 2021 using their 2019 tax information
- Follow the instructions carefully
- Submit- FAFSA applications are typically processed within three to five days. Once processed you will receive a copy of your student aid report which includes your expected family contribution which determines your eligibility for Pell Grants.

MSFFA for Non-Citizens or Green Card Holders

For applicants to receive aid when they cannot apply for FAFSA - this will be covered in the financial aid presentation

* Send Test Scores

Test scores must be sent directly from College Board (SAT) or ACT-if you do not select your schools when you register for the SAT you will be charged \$15 to send your scores to each school

ACT - www.actstudent.org

*Many schools are test optional this year due to COVID-please discuss with your CCIC or counselor to determine whether or not you should send your score.

What's in a COMPLETE APPLICATION?

- Application Forms
- Application Fees \$50+ ask about fee waivers
- High School Transcript-pick up request form in Counseling office
- Final High School Transcript- Mailed AFTER the year ends
- Admission Test Scores-SAT/ACT sent directly from ACT or College Board
- Letters of Recommendation - Teachers and Counselor
- Essays
- Auditions and Portfolios
- Interviews-Not all schools require an interview

Montgomery College

- Simple online application. Can apply October 1st! FREE for MCPS students!!
- Due date for the Scholars Program and Macklin Program is in January 2021. Separate application. \$25 fee
- Students may have to take the Accuplacer if they do not have an ACT or SAT score OR if scores are not a 21 or higher for the ACT or a 520 or higher on the Math SAT. (Rules may be different during COVID)
- Take assessment tests before class registration.

Important Reminders:

- Pay Attention to application deadlines
- Get your brag sheet written BEFORE you ask for letters of recommendation
- Allow 15 days for your teachers to write your letters and your registrar to get all your documents in order
- Check your email on a regular basis, MHEC will send you an email if you are awarded money
- SSL Hours - Don't wait to get your SSL Hours- Set a goal to get them completed by March. See your counselor if you have any questions
- Obligations - Make sure all your obligations are paid
