#### **I support:**

- Creating a uniform, student evaluation system of teachers similar to the system at Montgomery College
- Returning driver's ed classes to the curriculum to save students time and money

- Working with individual high schools to develop open lunch policies
- Expanding the current high school cell phone policy to all middle schools
- Increasing SMOB voting rights
- Approving a comprehensive sex education curriculum
- Opening up some school activities to students who do not meet the 2.0 GPA requirement
- Exempting students from final exams if they are taking that subject's AP exam

*Question 1: What would be your top three realistic priorities as the Student Member of the Board of Education?*

The SMOB only has one year to make a difference in our school system. If elected, I will focus my efforts on three main areas:

- 1) Improving academic life by bringing back driver's education to the curriculum to save students time and money and by exempting students from final exams if they have taken an AP exam in a course.
- 2) Improving communication between the SMOB and students by creating an email listserv for electronic updates and by publishing a quarterly newsletter.
- 3) Improving equality in student life by working to close the minority achievement gap and by instituting a student evaluation system of teachers.

*Question 2: What qualities and performance goals would you consider for hiring or contract renewal of our superintendent?*

The Superintendent is the educational and administrative director of the school system and as a result has the greatest influence on student life. If elected, I will look for a person who can achieve measurable results and who is passionate about eliminating the minority achievement gap, reducing class sizes, and implementing the grading policy uniformly and consistently. Most importantly, I will look for a candidate who listens to our voice and who cares about student opinions.
